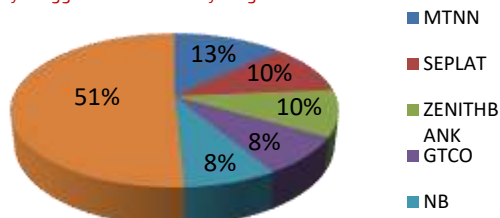

Price Appreciations in CHAMPIONS, JOHNHOLT, FBNH Sustained NGX-ASI Rally by +17bps; NIBOR Quiet Across Tenors, NITTY Ended in Mixed-bag...

The NGX on Friday sustained its bullish run for the third consecutive day as the benchmark ASI rose by 0.17% to close at 51,705.61 points despite the Exchange printing a higher number of losers (18) against the gainers (12). Consequently, the YTD advanced to 21.04 as the market capitalization increased by N46.8 billion to N27.87 trillion from N27.82 trillion. Leading the chart for gainers were CHAMPIONS (10.0%), JOHNHOLT (8.6%), MAYBAKER (8.5%), INTBREW(5.3%), and FBNH which gained 4.5% as a result of price appreciations. Performance across sub-sector gauges was largely bearish as witnessed in NGX Insurance Index (-0.71%), NGX Consumer Goods (-0.56%), NGX Oil/Gas (-0.46%) except for the NGX Banking index which rose +6bps, and the NGX Industrial index stayed flat from the previous day. Elsewhere, Market activity was weak today, as the volume of stocks traded fell by 99.93% to 156.09 million units; Similarly, the value of stocks traded decreased by 35.82% to N1.83 billion. Meanwhile, NIBOR traded flattish today for all tenor buckets tracked but it was a mixed outing for NITTY for all maturities tracked on renewed buy interest in the 1m and 3m tenors and then the 6m and 12m tenors declined -16bps and -9bps respectively. In the OTC bonds market, the values of the FGN bonds were positive for most maturities tracked except for FGNMAR2035 which closed -32bps; then the values of FGN Eurobond trended in the green for all maturities tracked due to healthy demand.
