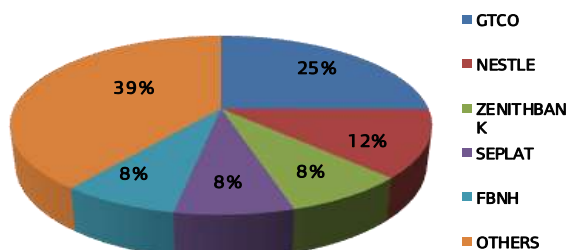

## Sell-Offs in major Tickers Drove Mixed Sentiments as ASI Shed -1.5bps; NIBOR Slid Southward Amid Liquidity Boost, NITTY On The Rise.....

Mixed sentiments pervaded the domestic bourse on Wednesday from sell-pressure as the NGX-ASI and market capitalization shed marginally -0.003ppts to close at 51,802.48 points and N27.927 trillion respectively while the market YTD returns remain unchanged at 21.27% even as the Exchange printed a higher number of gainers (17) than losers (14). Consequently, IKEJAHOTEL (10.00%) witnessed an uptick in its price to lead the gainers' table and trailed by ROYALEX (7.29%), NPFMCRCFBK (7.27%), FIDELITYBK (4.88%) and GLAXOSMITH (4.84%) in that order. Elsewhere, trading activities were mixed as the total volume accelerated 32.38% to 416.47 million while the total value traded tanked 73.08% to N3.46 billion from 4,466 deals. Given the muted close at midweek, performance across the sectoral front was bullish except for the NGX Banking index which trended southward by 7bps resulting from sell-offs in GTCO, UBA, FBNH, and ACCESSCORP respectively. Thus, the NGX Insurance (+0.46%), NGX Consumer Goods (+0.09%), NGX Oil/Gas (+0.07%) while the NGX Industrial Goods closed flat. Elsewhere, NIBOR rates fell across tenor buckets save for the 3 months which rose 0.54% amid sustained liquidity boost while the NITTY rose for most maturities tracked. Meanwhile, the values of the FGN bonds remained largely flattish for most maturities tracked, and then the FGN Eurobonds yields rose further for all maturities tracked.
