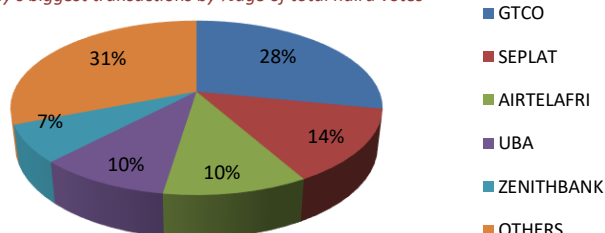

**Domestic Bourse Ends the Week in Green, as NGX ASI gains marginally by 2bps; NITTY Falls for most Tenor Buckets Tracked on Buy Pressure...**

The local bourse rose marginally by 0.02% to close at 51,829.67 points amid sustained positive sentiment. The Exchange printed a higher number of gainers (20) than losers (16) as the year-to-date gain of the bourse rose to 21.33%. TIP gained 10.00% to lead the best five performing stocks in the session; Also, we saw buying interest in Tickers such as PZ, UNILEVER, AIICO, ACCESSCORP, TRANSCORP and SEPLAT, leading to 6.25%, 3.38%, 3.13%, 1.62%, 0.81% and 0.04% increase in their respective share prices. Given the northward movement in the benchmark index, performance across sub-indices was largely positive except for the NGX Consumer Goods index and the NGX Oil/Gas index which fell by 0.01% and 0.39% respectively. The NGX Banking index, NGX Insurance index, and the NGX Industrial index rose by 0.36%, 1.23% and 0.04% respectively. Elsewhere, Market activity was weak today, as the volume of stocks traded dipped by 43.06% to 127.03 million units; While, the value of stocks traded decreased by 55.93% to N1.71 billion. Meanwhile, NIBOR moved in mixed directions. Elsewhere, NITTY rose for most maturities tracked amid sustained sell pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid sustained sell Interest.
