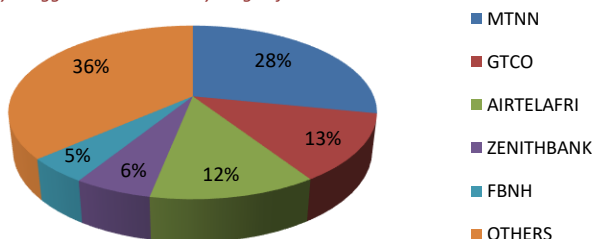

Profit-taking Dips Local Bourse by 0.07%, as the Week Starts Negative; NIBOR Falls for most Tenor Buckets Tracked amid Financial System Liquidity Ease...

The domestic equities market All-Share index fell by 0.07% to close at 51,791.45 points as investors unloaded shares of CONOIL (-9.90%), AIICO (-7.58%), NB (-5.02%), WAPCO (-1.51%), ACCESSCORP (-1.06%), TRANSCORP (-0.81%) and FBNH (-0.43%) at lower prices today. Hence, the year-to-date gain of the index decreased to 21.25% even as the Exchange printed higher number of losers (19) than gainers (16). Given the southward movement in the benchmark index, performance across sub-indices was largely negative except for the NGX Banking index and the NGX Insurance index which rose by 0.17% and 0.14% respectively. The NGX Consumer Goods index, NGX Oil/Gas index and the NGX Industrial index fell by 0.94%, 0.35% and 0.12% respectively. Elsewhere, Market activity was strong today, as the volume of stocks traded ballooned by 52.82% to 194.12 million units; While, the value of stocks traded revved up by 65.33% to N2.82 billion. Meanwhile, NIBOR fell for all tenor buckets tracked amid ample liquidity in the financial system. Elsewhere, NITTY fell for all maturities tracked amid buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for all maturities tracked. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid renewed bearish sentiment.
