

NGX Index slides lower by 0.30% on Sustained Sell-Pressure; NIBOR Rises for Most Tenor Buckets amid sustained Financial System Liquidity Strain...

The local bourse All-Share index declined by 0.06% to close at 51,556.54 points amid sustained bearish sentiment. Specifically, sustained sell-off was witnessed on NEM (-10.00%), CHAMPION (-10.00%), UBN (-9.76%), INTEBREW (-5.26%) and GTCO (-0.73%) shares. Given the sustained bearish trend, the year-to-date gain of the index mellowed to 20.70% despite the Exchange printing a higher number of gainers (17) than losers (16). Nevertheless, the sub-sector gauges were largely negative – the NGX Banking, the NGX Insurance, the NGX Consumer Goods and the NGX Oil/Gas declined by 0.60%, 1.36%, 0.03% and 0.16% respectively. The NGX Industrial index remained unchanged. Elsewhere, Market activity was weak today, as the volume of stocks traded fell by 42.35% to 135.26 million units; While, the value of stocks traded decreased by 44.02% to N1.44 billion. Meanwhile, NIBOR rose for most tenor buckets tracked as liquidity dried up in the financial system. Elsewhere, NITTY also rose for most maturities tracked amid sustained sell pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for all maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid renewed bearish sentiment.
