The NGX closes the week with marginal loss amidst mixed investors sentiments; NIBOR Falls for Most Tenor Buckets on Liquidity Ease...

The local bourse All-Share index fell marginally by 1bps to close at 51,557.41 points as market continued trading at a tight range, as investors await H1 results. Hence, the year-to-date gain of the index dropped slightly to 20.70% despite, the Exchange printing a higher number of gainers (13) than losers (12). Specifically, we saw bullish sentiment on symbols such as CAVERTON (+9.91%), ACADEMY (+9.88%), NEIMETH (+9.40%), COURTVILLE (+6.52%) and UPDC (+5.98%). On the weak side, NAHCO share price fell by 7.31%, followed by CORNERST (-5.48%), CHIPLC (-4.00%) and JAPAUGOLD (-3.57%). Sectorial performance remained mixed bag – the NGX Banking and the NGX Oil/Gas rose by 0.15% and 0.09% respectively, while the NGX Insurance index and the NGX Industrial index fell by 0.74% and 0.05% respectively. The NGX Consumer Goods index remained unchanged. Elsewhere, Market activity was mixed today, as the volume of stocks traded fell by 19.65% to 115.13 million units; While, the value of stocks traded increased by 1.29% to N1.78 billion. Meanwhile, NIBOR fell for most tenor buckets tracked amid financial system liquidity ease. Elsewhere, NITTY dipped for most maturities tracked amidst buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond appreciated for most maturities tracked amid renewed bullish sentiment.



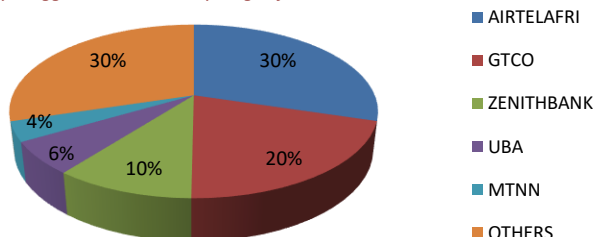
