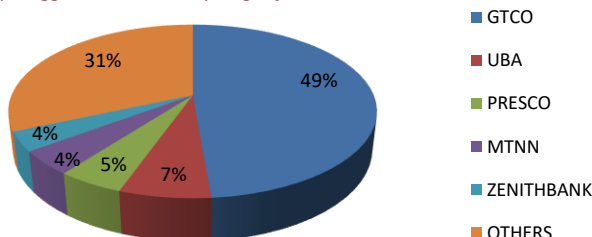

Equity Market Declines by 32bps on Dampen Investors' Appetite, as Bearish Sentiments Persist; NIBOR Falls for Most Tenor Buckets on Liquidity Ease...

Bearish Sentiment overshadowed the bullish momentum from Monday as the NGX All share Index fell by 0.32% to close at 51,557.41 points. Hence, the year-to-date performance of the index decreased to 20.31%, even as the Exchange printed a higher number of losers (25) than gainers (11). MULTIVERSE led the top five laggard's chart as its share price depreciated by 10.00%. REDSTAREX, CUTIX, UNITYBNK, LIVESTOCK and NAHCO fell by 9.82%, 8.33%, 8.16%, 7.97% and 7.19% respectively amid profit taking activities. Sectorial performance was weak at the end of closing - the NGX Insurance index, NGX Oil/Gas and the NGX Industrial index fell by 2.96%, 0.04% and 0.01% respectively, while the NGX Banking and the NGX Consumer Goods index rose by 0.05% and 0.31% respectively. Elsewhere, Market activity was strong today, as the volume of stocks traded rose by 72.69% to 198.82 million units; Also, the value of stocks traded increased by 22.65% to N2.18 billion. Meanwhile, NIBOR fell for most tenor buckets tracked amid sustained financial system liquidity ease. Elsewhere, NITTY rose for most maturities tracked amidst renewed buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked amid sustained bullish sentiment.
