

# Cowry Daily Market Insight 08 August 2022

### Sell Pressure In Banking Stocks Dips NGX-ASI By 0.46%; NIBOR Falls for most Tenor Buckets amid sustained Liquidity Ease...

The NGX's All-Share Index (ASI) declined by 0.46 % after the close of today's trading as the Exchange recorded 15 losers to 10 winners amid a persistent sell-pressure in the banking and industrial goods sectors. Consequently, the NGX ASI's year-to-date gain decreased to 18.20 percent. Specifically, ELLAHLAKES, ZENITHBANK, MTNN, FBNH, and GTCO tickers dropped by 9.60%, 2.97%, 2.28%, 1.37% and 0.49% respectively. As a result, sectorial performances closed mixed as the NGX Banking and NGX Industrial Goods indexes decreased by 1.10% and 0.01% respectively while the NGX Oil/Gas Indices stayed steady from the last close and then, the NGX Insurance Indices and the NGX Consumer Goods Indexes, on the other hand, recorded upticks by 1.36% and 0.17% respectively. Market activity level was strong today as the volume of stocks traded ballooned by 39.24% to 207.20 million units while the total value traded increased by 10.07% to N2.12 billion. Elsewhere, in the money market, NIBOR decreased for the majority of our tracked maturities as the liquidity in the financial system further loosened. NITTY also declined for the most of tenor buckets due to persistent buy demand. Further afield, into the bond space, the values of the FGN bonds under our watch in the OTC bond market stayed unchanged while the FGN Eurobond values, on the other hand, increased amid buy interest for all tracked maturities.
