





Cowry Daily Market Insight 12 August 2022

Equity Market Closed the Week Negative as NGX-ASI Declines by 70bps; NIBOR Falls for Most Tenor Buckets on Liquidity Boost...

Given the continued negative sentiment, the local bourse concluded the week adversely as its All Share Index (ASI) fell by 0.70% to close at 49,664.07 points. Hence, the NGX ASI's year-to-date gain declined to 16.27%. Furthermore, the Exchange recorded 24 losers vs 18 gainers, despite the fact that share prices of Tier-1 banks and other blue-chip stocks closed lower on sell pressure. Specifically, BUACEMNT, DANGCEM, FLOURMILL, ZENITHBANK, ACCESSCORP and GTCO fell by 9.95%, 2.34%, 1.37%, 0.70%, 0.56% and 0.24%. Performance across sub-sector gauges was negative, with three out of five indices closing lower, with the exception of the NGX Insurance Index and the NGX Consumer Goods index, which gained by 1.75% and 2.82%, respectively. The NGX Banking index, NGX Oil/Gas index, and NGX Industrial index all dipped by 0.19%, 0.16% and 4.61%, respectively. Meanwhile, trading activity was buoyant, with the volume of stocks moved increasing by 461.63% to 750.29 million units, and the total value of stocks traded increasing by 117.72% to N5.31 billion, owing largely to strong trading activity in CAPHOTEL ticker. Elsewhere, NIBOR fell across all tenor buckets tracked amid fresh financial sector liquidity injection; Similarly, NITTY fell across the board for all maturities tracked as buy pressure increased. Further afield, in the bond market, the values of FGN bonds in the OTC bond market remained stable for the majority of maturities tracked, whilst the values of FGN Eurobonds decreased on bearish activity.
