

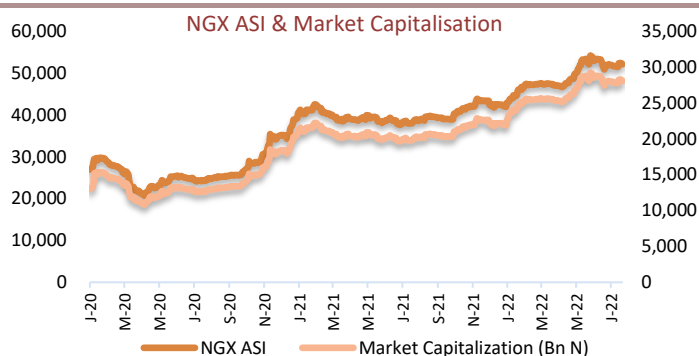

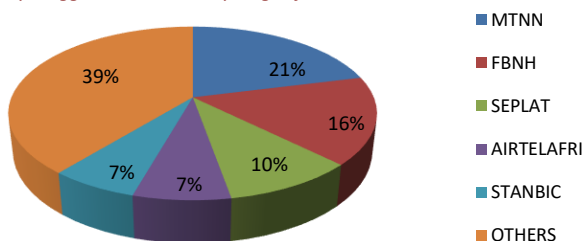

## Local Bourse Index Sheds 0.29% amid Sustained Bearish Activity; NIBOR Falls for Most Tenor Buckets on Liquidity Boost...

The Domestic Stock Exchange maintained its downward trend as the All-Share Index (ASI) dropped 0.29% to settle at 49,546.38 points at the end of the trading day. As a result, the year-to-date gain of the bourse decreased to 15.99%. In particular, the Exchange recorded more losers (24) than winners (12) as share prices of tickers including NEM (-9.98%), OKOMUOIL (-9.96%), CADBURY (-8.05%), FLOURMILL (-5.22%), ACCESSCORP (-1.76%), BUACEMENT (-1.37%), and MTNN (-0.38%) closed lower. Additionally, performance across subsectors remained negative as four of the five tracked indices closed in negative territory, except the NGX Banking index, which increased by 0.18%. A fall of 1.41%, 0.33%, 0.10%, and 0.51%, respectively, was seen in the NGX Insurance index, NGX Consumer Goods index, NGX Oil/Gas index, and NGX Industrial index. Meanwhile, market activity was mixed, with the number of shares traded climbing by 14.13% to 146.99 million units, while the total value dipped by 35.75% to N2.65 billion. Elsewhere, as financial sector liquidity improved, NIBOR fell across all tenor buckets; additionally, NITTY fell across most maturities tracked as buy pressure increased. In the OTC bond market, the value of FGN bonds remained unchanged for most tracked maturities. However, due to sustained bearish sentiment, the value of FGN Eurobonds decreased for all tracked maturities.
