

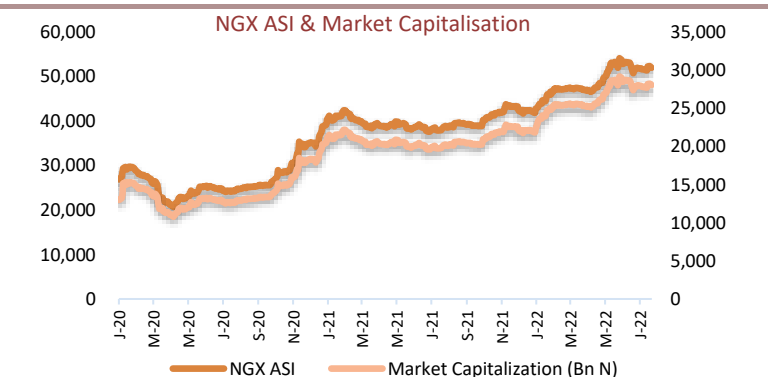

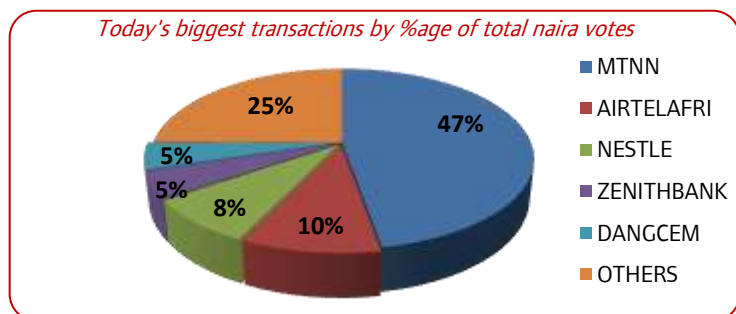
Bears Hold Ground on Bargain Hunting in Banking Stocks as NGX-ASI Dipped 7bps; NIBOR on Moderation as Liquidity Tightens.....

The local bourse sustained its bearish run for the second straight day this week as cherry-picking activities stole the show on Tuesday, driving the benchmark index 7bps to 49642.69 points while the market cap lost N18.37 billion to settle at N26.78 trillion from N26.79 trillion on last close. This, however, left the market with the same gainers (13) and decliners (13) as the YTD return toned-down to 16.21%. As investors continue seeking market direction with heavy bargain-hunting activities, the NGX Banking index was the lone decline (-0.13%) across the sectoral gauges under our watch and was driven by strong sell-offs in ACCESSCORP, GTCO, FCMB, and STERLING. On the contrary, the NGX Oil and Gas (+0.10%), NGX Insurance (+0.08%), and NGX Consumer Goods (+0.001%) indexes recorded gains due to strong demand in CONOIL, CHIPLC, FLOURMILL while the NGX Industrial Index traded in a quiet zone on Tuesday. Further afield, trading activity was mixed as the number of shares traded declined by 45.93% to 125.95 million units, while the total value improved by 40.57% to N3.07 billion. Driving into the money market, NIBOR moderated across all tenor buckets, with the overnight lending rate accelerating by 28bps to 14.85% due further liquidity tightening. Also, NITTY rose for all maturities monitored. In the OTC bond market, the values of FGN bonds were muted for all maturities tracked. Meanwhile, the value of FGN Eurobonds declined across the board for all maturities amid persistent rise in yields.
