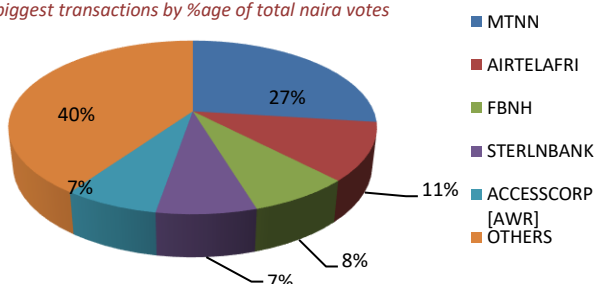

## GUINNESS, FBNH, and Others Lift NGX-ASI by 0.39%; NIBOR Rises for most Tenor Buckets amid Liquidity Squeeze...

At the close of Wednesday's trading session, the domestic bourse index rose by 0.39% to settle at 49,836.51 points as investors hunted for bargains on blue-chip stocks. We saw the share prices of GUINNESS, FIDELITYBK, WAPCO, BUAFOODS, and FBNH close higher by 9.88 %, 4.93%, 4.60%, 4.48%, and 2.29%, respectively. Consequently, the year-to-date gain of the local bourse rose to 16.69% even as the Exchange printed more gainers (20) than losers (12). Four of the five tracked indexes—NGX Banking, NGX Consumer Goods, NGX Oil/Gas, and NGX Industrial—closed in the green, indicating strong sectoral performance. These indices saw increases of 0.62%, 1.80%, 0.33% and 0.37%, respectively. In contrast, the NGX Insurance index fell by 0.10%. Meanwhile, trading activity was upbeat as the number of shares traded increased by 191.66% to 367.34 million units, also the total value climbed by 5.35% to N3.23 billion. In the money market, NIBOR rose across most tenor buckets amid financial system liquidity strain, despite the open buyback rate and overnight lending rate both falling by 11 basis points and 10 basis points, to 8.00% and 8.67%, respectively. Meanwhile, NITTY declined for the majority of tracked maturities on demand pressure. In the OTC bond market, the values of FGN bonds were muted for all maturities tracked. Meanwhile, the value of FGN Eurobonds fell across the board for all maturities amid sustained bearish sentiment.
