

Equity Market Gains N28billion, As NGX-ASI Advances By 0.11%; NIBOR Falls for All Tenor Buckets on Liquidity Boost...

At the end of Thursday's trade, the domestic bourse closed positive as the All-Share Index rose by 0.11% to 49,652.25 points. Consequently, the year-to-date gain of the NGX ASI advanced to 16.24%. Given the positive sentiment, the Exchange printed a higher number of gainers (20) than losers (9). Notably, small and mid-cap stocks such as ARDOVA (+8.94%), UBN (+7.14%), FIDELITYBK (+4.96%), FCMB (+2.80%), WAPCO (+1.88%), TRANSCORP (+1.85%) and UBA (+1.39%) were the toast of investors today. Sectorial performance was positive as four of the five sub-sector indices tracked closed in the green territory: the NGX Banking, NGX Insurance, NGX Oil/Gas, and the NGX Industrial indices rose by 1.07%, 0.76%, 0.37%, and 0.16%, respectively, while the NGX Consumer Goods fell by 0.15%. Meanwhile, trading activity was mixed, as the volume of stocks traded rose 25.55% to 161.88 million units, while the total value of stocks traded fell 2.50% to N1.63 billion. The most traded stocks by volume were TRANSCORP (34.4 million shares), FIDELITYBK (101.72 million shares), and STERLNBANK (19.82 million shares), while MTNN (N692.2 million), ZENITHBANK (N166.05 million), and FIDELITYBK (N101.72 million) led by value.



Money Market

The CBN maintained its position on curbing inflation by raising all T-bill rates at the most recent auction. Stop rates increased to 5.50%, 5.85%, and 10.00% for the 91-day, 182-day, and 364-day, respectively. NITTY, however, moderated for the majority of tracked maturities. NIBOR fell for all the tenor buckets tracked as banks with liquidity requested lower rates, as the open buyback rate fell 26 bps and 25 bps to 9.67% and 10.17%, respectively.

Bonds Market

In the OTC bond market, the values of FGN bonds were muted for all maturities tracked. Meanwhile, the value of FGN Eurobonds rose for most maturities tracked on sustained demand pressure

Foreign Exchange Market

The Naira appreciated against the US dollar at the I&E windows, gaining 0.05% to settle at N436.3 from N436.5, while the parallel market rate stayed flat at N705.

Global Oil Market

Oil prices recovered from a 7-month low on Thursday after Russia threatened to halt supply to unfriendly countries. This came in despite fears over global economic slowdowns, aggressive monetary tightening, and COVID lockdowns in China. As of 4:00 p.m. GMT +1, Brent Crude, the oil benchmark, is trading up 0.92% at \$88.81 per barrel. Similarly, WTI crude oil was trading up 1.44% at \$83.12%.
