

Nigerian Equities Market Index Advances by 0.09%; NIBOR Rises for most Tenor Buckets on Liquidity Squeeze...

The local stock exchange maintained its upward trend as the All-Share Index increased by 9 basis points (bps) to settle at 49,695.12 points amid persistent bargain hunting. The increase in UBA's share price contributed to the robust performance in the stock market today. Other large and mid-cap equities, such as NEM, FCMB, FLOURMILL, ACCESSCORP, and WAPCO stocks, also saw bargain-hunting activity. As a result, the share prices of each company increased by 7.62%, 6.06%, 3.41%, 2.31%, and 1.84%, respectively. Hence, the year-to-date gain of the local bourse rose to 16.34% despite the Exchange printing 16 losers as against 10 gainers at the close of the session. We saw bullish performance across most sub-sectors as four of the five indexes tracked closed in green: the NGX Banking, NGX Insurance, NGX Consumer Goods, and the NGX Industrial indices rose by 0.87%, 0.44%, 0.06%, and 0.15%, respectively, while the NGX Oil/Gas fell by 0.16%. Elsewhere, market activity came in stronger as UBA printed N400.3 million worth of transactions today. Consequently, the volume and value of stocks ballooned by 97.11% and 14.60% to 319.09 million units and N1.86 billion, respectively. The most traded stocks by volume were STERLNBANK (173.84 million shares), UBA (54.07 million shares), and ZENITHBANK (14.02 million shares), while UBA (N400.61 million), MTNN (N289.47 million), and ZENITHBANK (N281.44 million) led by value.



Money Market

Despite the open buyback rate and overnight lending rate both falling by 12 basis points to 8.50% and 9.00%, respectively, NIBOR increased for the majority of maturities tracked as banks with liquidity demanded higher rates. Similarly, NITTY rose for the majority of tracked maturities amidst sell pressure.

Bonds Market

In the OTC bond market, the values of FGN bonds were muted for most maturities tracked. Meanwhile, the value of FGN Eurobonds rose for most maturities tracked on sustained demand pressure.

Foreign Exchange Market

At the I&E windows, the Naira depreciated marginally versus the US dollar, losing 0.01% to close at N436.33 from N436.30. The parallel market rate also declined, falling to N708 from N705 by 0.43%.

Global Oil Market

As of 4:00 PM GMT +1, Brent crude is trading up 3.30% at \$86.29 a barrel. Similarly, WTI crude oil was trading 3.13% higher at \$91.94. This emerged as investors balanced the dangers of a recession in the world economy against those of a decline in supply. Despite Friday's rebound, the oil market remains gloomy, with both Brent and WTI crude oil set for weekly losses, with Brent down approximately 1.40% on the week. WTI was on track for a weekly drop of 0.91%.
