

Insurance, Oil and Gas Sectors Sustain Local Bourse Decline, As NGX-ASI Falls By 0.07%, NIBOR Rises for all Tenor Bucket on Financial System Liquidity Squeeze..... The local Bourse started the week in the red, with the All-Share index down 0.07% to close at 49,440.21 points. As a result, the index's year-to-date performance fell to 15.74% despite the market's breadth closing flat with 11 losers and 11 gainers. Share prices of SEPLAT, MANSARD, UCAP, and GTCO fell 3.85%, 2.86%, 0.42%, and 0.25%, respectively, due to persistent sell pressure. Performance across sub-sector gauges was mixed as the NGX Banking index and the NGX Consumer Goods index rose by 0.28% and 0.17% respectively, while the NGX Insurance Index and the NGX Oil/Gas index fell by 0.25% and 1.94%, respectively. The NGX Industrial index remained unchanged. Meanwhile, trading activity remained robust, with total trade and value increasing by 2.51% and 28.70%, respectively, to 3,386 trades and N1.48 billion. However, the total traded volume fell 37.33% to 107.49 million units. In terms of volume, FBNH was the most active stock, with 9.67 million shares worth N96.56 million changing hands in 185 trades. SEPLAT had the most traded stock in terms of turnover, at N615.12 billion.



Money Market

NIBOR increased across the board for all maturities monitored as banks with liquidity sought higher rates, with the overnight lending rate and the open buyback rate rising 7 bps and 6 bps to 10.33% and 10.83%, respectively. This came as investors weighed the Debt Management Office (DMO) decision to hold the primary market auction today.

Likewise, NITTY rose for all tenor buckets tracked amid sell pressure.

Bonds Market

In the OTC bond market, the values of FGN bonds remained unchanged for most maturities tracked. On the flip side, the value of FGN Eurobonds appreciated for all maturities tracked on renewed bullish sentiment.

Foreign Exchange Market

The Naira depreciated against the US dollar at the I&E windows, dropping 0.06% to N436.50 from N436.25. The rate on the parallel market declined as well, going from N709 to N712 by 0.42%.

Global Oil Market

As of 4:00 p.m. GMT+1, Brent crude is down 0.29% to \$91.09 a barrel. Likewise, WTI crude oil fell 0.43% to \$84.75 per barrel. The likelihood of a stronger dollar and potential rate increases this week by the US Federal Reserve exacerbated the fall.
