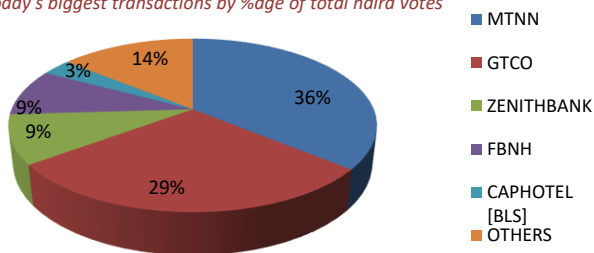

Equities Market Index Rises Marginally by 0.01% amid Renewed Bullish Activity; NIBOR Rises for all Tenor Bucket amid Liquidity Squeeze...

The local bourse index gained marginally by 0.01% at the end of Tuesday's trade to settle at 49,445.31 points, reflecting improved investor confidence. Consequently, the year-to-date gain of the NGX ASI rose to 15.75% despite the Exchange printing more losers (14) than gainers (11). Notably, RTBRISCOE, FBNH, LINKASSURE, FIDELITYBK, and ZENITHBANK were the toast of investors today, with their respective share prices rising by 10.00%, 5.00%, 4.35%, 2.05%, and 0.25%. Sectorial performance was negative as three out of the five indices tracked closed in the red zone; the NGX Consumer Goods index, NGX Oil/Gas index, and the NGX Industrial index declined by 0.05%, 2.30%, and 0.01%, respectively. On the flip side, the NGX Banking index and the NGX Insurance Index rose by 0.22% and 0.15%, respectively. Meanwhile, trading activity remained upbeat, with total volume and value increasing by 119.07% and 61.72%, respectively, to 147.59 million units and N2.39 billion. However, the overall number of deals declined 1.86% to 3,323 trades. In terms of volume, GTCO was the most active stock, with 35.82 million shares worth N693.69 million changing hands in 354 deals. MTNN was the most traded stock in terms of turnover, at N860.12 billion.

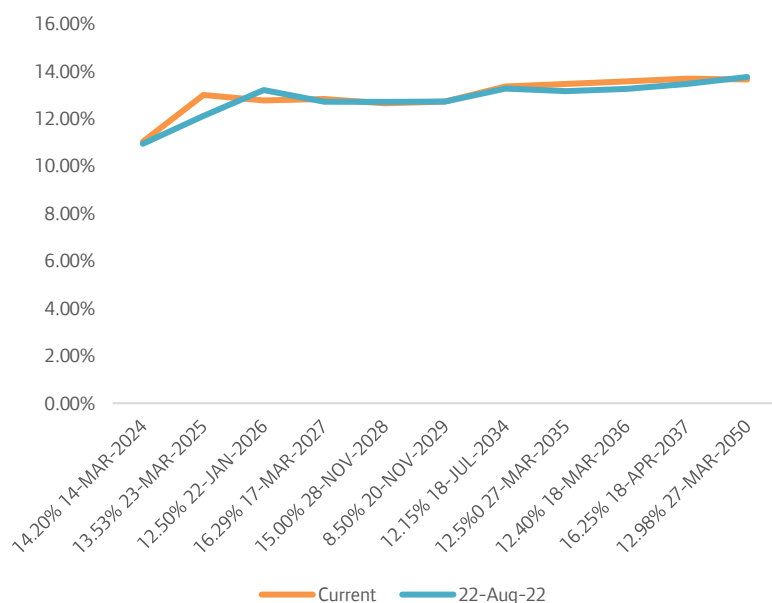

Money Market

NIBOR jumped across the board for the majority of maturities tracked as banks with liquidity demanded higher rates, with the overnight lending rate and the open buyback rate moving 6 basis points and 4 basis points, respectively, to 11.00% and 11.25%.

Similarly, NITTY increased across all tenor buckets tracked under persistent sell pressure.

Bonds Market

In the OTC bond market, the values of FGN bonds remained unchanged for most maturities tracked. On the flip side, the value of FGN Eurobonds depreciated for all maturities tracked amid bearish sentiment.

Foreign Exchange Market

At the I&E windows, the Naira gained 0.06% against the US dollar, rising to N436.25 from N436.50. The parallel market rate, however, remained constant at N712.

Global Oil Market

As of 4:00 p.m. GMT+1, Brent crude is down 1.12% to \$90.97 a barrel. Likewise, WTI crude oil fell 1.63% to \$84.33 per barrel. Oil prices and other risk assets are under pressure as investors speculate on the US Federal Reserve's expected rate hike on Wednesday to curb inflation.
