Cowry Daily Market Insight 21 September 2022

NGX All-Share Index Falls by 5bps amid Renewed Profit Taking Activity; NIBOR Rises for All Tenor Buckets on Liquidity Strain...

The local bourse All-Share index fell 0.05% in low-volume trading to settle at 49,421.91 points, as profit-taking resumed. Furthermore, the Exchange printed a higher number of losers (12) than gainers (10) as tickers such as ACADEMY (-9.78%), NEM (-6.08%), CADBURY (-5.45%), JAIZBANK (-4.76%) and NGXGROUP (-4.38%) were among the worst performing stocks. Hence, the year-to-date gain of the index declined to 15.70%. Given the bearish sentiment, the NGX Insurance index, NGX Consumer Goods index, NGX Oil/Gas index, and NGX Industrial index all fell by 1.21%, 0.02%, 0.10%, and 0.03%, respectively. Conversely, FIDELITYBK, STANBIC, UBA, and ZENITHBANK share prices increased by 5.46%, 1.69%, 1.38%, and 0.76%, respectively, lifting the NGX Banking index by 0.49%. Meanwhile, trading activity was subdued, with total transactions, volume, and value falling by 10.29%, 64.85%, and 75.35%, respectively, to 2981 trades, 51.88 million units, and N590.01 million. ZENITHBANK was the most active stock in terms of volume and turnover, with 6.30 million shares worth N125.54 million changing hands in 296 transactions. Trading volumes on the NGX have been light, contributing to the seesaw trading sessions that we have seen, with investors only confident enough to take short-term trading positions.



Money Market

NIBOR jumped across the board for all the maturities tracked as banks with liquidity demanded higher rates, with the overnight lending rate and the open buyback rate moving 15 basis points and 17 basis points, respectively, to 12.67% and 13.17%.

However, NITTY was flattish for all tenor buckets tracked as investors lack direction.

Bonds Market

In the OTC bond market, the values of FGN bonds remained unchanged for most maturities tracked as investors remained on the sidelines. On the flip side, the value of FGN Eurobonds appreciated for all maturities tracked amid renewed bullish sentiment.

Foreign Exchange Market

At the I&E windows, the Naira lost 0.06% against the US dollar, falling to N436.50 from N436.25. The parallel market rate, however, remained constant at N712.

Global Oil Market

As of 4:00 p.m. GMT+1, Brent crude is down 0.54% to \$90.13 a barrel. Likewise, WTI crude oil fell 0.58% to \$83.45 per barrel. Oil prices gave up early gains on Wednesday after the U.S. Energy Information Administration reported a crude oil inventory build of 1.1 million barrels last week. This offset early gains of almost 3% as a result of concerns of further supply disruptions given President Vladimir Putin announcement of a partial military mobilization in Russia. Oil price Outlook looks gloomy as the likelihood of a stronger dollar and the US Federal Reserve's expected rate hike could dampen global energy demand
