Nigerian Equities Market Index falls by 0.33% amid Sustained Sell-Pressure; NIBOR Rises for All Tenor Buckets amid Liquidity Strain...

The Nigerian stock exchange All Share-Index nosedived by 0.33% to close at 49,026.62 points, significantly below the day's high of 49,309.63 points but higher than the session low of 48,994.15 points. BERGER (-9.85%), ETERNA (-9.45%), WAPIC (-5.41%), BUACEMENT (-4.49%), and GTCO (-3.14%) all took a beating today, resulting in share price declines. Consequently, the year-to-date gain of the index mellowed to 14.77% even as the Exchange printed a higher number of losers (22) than gainers (11). Given the market's continued bearishness, most sub-sector indices declined; the NGX Insurance index, NGX Oil/Gas index, and NGX Industrial index all slipped by 0.46%, 0.21%, and 1.61%, respectively. However, the share prices of ACCESSCORP, FIDELITYBK, UBA, INTBREW, and CADBURY gained by 6.02%, 3.00%, 1.39%, 0.99%, and 0.85%, respectively, lifting the NGX Banking Index and the NGX Consumer Goods index. Meanwhile, trading activity was strong, with total deals, volume, and value rising by 2.85%, 33.38%, and 79.16%, respectively, to 3,206 trades, 169.18 million units, and N3.19 billion. In terms of volume, COURTVILLE was the most active stock, with 27.68 million shares worth N12.49 million changing hands in 8 trades. MTNN had the most traded stock in terms of turnover, at N1.28 billion.



### Money Market

As banks with liquidity sought higher rates, NIBOR jumped across the board for all maturities tracked, with the overnight lending rate and open buyback rate rising 5 basis points and 2 basis points, respectively, to 14.83% and 15.00%.

Similarly, NITTY declined across all tenor buckets tracked amid sustained demand pressure.

#### **Bonds Market**

As investors remained on the sidelines in the OTC bond market, the values of FGN bonds remained steady for the majority of the maturities tracked. In contrast, the value of FGN Eurobonds fell across all maturities monitored, reflecting renewed bearish sentiment.

### Foreign Exchange Market

At the I&E windows, the Naira gained 0.04% against the US dollar, rising to N436.33 from N436.50. The parallel market rate increased by 0.28%, rising from N714 to N712.

#### Global Oil Market

As of 4:00 p.m. GMT+1, Brent crude is down 5.15% to \$85.80 a barrel. Likewise, WTI crude oil fell 5.95% to \$78.52 per barrel. Oil prices fell to levels not seen since January on Friday, owing to increased fears of a global recession, a stronger US currency, and the potential for more aggressive interest rate rises by major central banks across the world, which would reduce energy demand. While sentiment remains gloomy, the market still has a lot of upsides given better oil demand from key Chinese importers; potential further OPEC output cuts; and the possibility of Russia intensifying the continuing crisis in Ukraine. We anticipate a volatile and unpredictable next quarter as the Powell versus Putin battle intensifies.
