Local Bourse Index rises by 0.33% amid Gains on BUACEMENT, WAPIC, Banking Shares; NIBOR Moves Southward for Most Tenor Buckets amid Liquidity Ease...

The domestic stock market index advanced by 0.33% to close at 49,189.32 points, significantly below the day's high of 49,226.12 points but higher than the session low of 49,053.91 points. We saw buying interest in tickers such as FCMB, UBN, BUACEMENT, WAPIC, and GTCO. Hence, their respective share prices increased by 8.02%, 7.83%, 5.43%, 2.86%, and 1.89%. Consequently, the year-to-date gain of the local bourse rose to 15.15%. The Exchange printed a higher number of losers (17) than gainers (12) despite investors reshuffling their holdings to positions in banking and industrial shares. Despite the bullish sentiment, performance across sub-indices studied was negative, with three of the five sub-sector indicators monitored moving south. The Insurance NGX index, the NGX Consumer Goods index, and the NGX Industrial index fell 2.61%, 0.11%, and 0.34%, respectively. The NGX Banking Index and the NGX Oil/Gas Index, on the other hand, gained by 0.52% and 1.89%, respectively. Meanwhile, trading activity was weak, with total volume and value falling by 29.49% and 73.22%, respectively, to 119.28 million units and N854.76 million. In terms of volume, COURTVILLE was the most active stock, with 24.36 million shares worth N10.96 million changing hands in 11 trades. ZENITHBANK had the most traded stock in terms of turnover, at N177.13 million.



Money Market

As banks with liquidity sought lower rates, NIBOR fell across the board for the majority of maturities tracked, with the open buyback rate falling 2 basis points to 14.50% and 14.83%.

NITTY, on the other hand, moved in mixed directions.

Bonds Market

As investors remained on the sidelines in the OTC bond market, the values of FGN bonds remained steady for the majority of the maturities tracked. In contrast, the value of FGN Eurobonds fell across all maturities monitored, reflecting sustained bearish sentiment.

Foreign Exchange Market

The Naira appreciated marginally at the I&E windows, rising from N436.50 to N436.33 against the US dollar. However, the rate on the parallel market fell, declining from N712 to N714 by 0.28%.

Global Oil Market

As of 4:00 p.m. GMT+1, Brent crude is down 0.03% to \$86.13 a barrel. Meanwhile, WTI crude oil rose 0.15% to \$78.86 per barrel.

As investors weighed the risks of more supply disruptions against the risks of weakened global energy demand, oil prices rose from a ninemonth low. The effects of a stronger dollar and additional tightening from major central banks could be mitigated by the potential for additional EU penalties against Russian crude oil as well as additional OPEC output cutbacks.
