


MPR: 15.50% Aug'22 Inflation Rate: 20.52% Q2 2022 Real GDP: 3.54%

NGX All-Share Index Falls by 0.06% as CBN hikes benchmark interest rate; NITTY Falls for All Tenor Buckets on Sell Pressure.

The local bourse All-Share index moderated by 0.06% to close at 49,161.45 points, significantly below the day's high of 49,223.31 points but higher than the session low of 49,154.50 points. The renewed market rout on the local bourse follows the Monetary Policy Committee's (MPC) September 27 hike in the Monetary Policy Rate (MPR) by 150 basis points (bps) to a 20-year high of 15.50%. The latest rate rise would exacerbate the existing gloomy sentiment on the Exchange, as rising fixed income rates would make the equity market less appealing to investors. As a result, the local bourse's year-to-date gain slipped to 15.08%. Furthermore, the Exchange printed more losers (17) than gainers (13). MAYBAKER, VITAFOAM, UNILEVER, ACCESSCORP, and UBA's stock prices fell by 9.79%, 6.98%, 5.38%, 4.55%, and 1.39%, respectively. Performance was mixed across sub-indices. The NGX Insurance index and the NGX Oil/Gas index both saw gains of 0.06% and 0.20%, respectively, while the NGX Banking index and the NGX Consumer Goods index had declines of 0.65% and 0.52%, respectively. However, the NGX Industrial index closed flat. Meanwhile, trading activity was upbeat, with total deals, volume, and value rising by 2.77%, 72.87%, and 176.38%, respectively, to 3,679 trades, 206.20 million units, and N2.36 billion. In terms of volume, TRANSCORP was the most active stock, with 38.46 million shares worth N38.99 million changing hands in 113 trades. ZENITHBANK had the most traded stock in terms of turnover, at N698.13 million.



Money Market

Given the Apex Bank's recent MPR hike, fixed income yield appears more appealing to investors, resulting in increased demand for T-bills in the secondary market. Consequently, NITTY declined across all tenor buckets tracked under fresh buy pressure.

Elsewhere, NIBOR moved in mixed directions.

Bonds Market

As investors remained on the sidelines in the OTC bond market, the values of FGN bonds remained steady for the majority of the maturities tracked.

In contrast, the value of FGN Eurobonds fell across all maturities monitored, reflecting sustained bearish sentiment.

Foreign Exchange Market

At the I&E windows, the Naira slightly declined in value against the US dollar, dropping from N436.30 to N436.33. The rate also plummeted by 1.26% from N714 to N723 on the parallel market.

Global Oil Market

As of 4:00 p.m. GMT+1, Brent crude is up 3.06% to \$86.63 a barrel. Meanwhile, WTI crude oil rose 2.61% to \$78.71 per barrel.

A weakening dollar and potential supply disruptions in the US Gulf due to Hurricane Lan both contributed to the price increase in oil prices today.
