

NCX All-Share Index Rises by 0.12% amid Gains on JAIZBANK, FBNH, GUINNESS Shares; NIBOR Rises Further for Most Maturities amid Tight Financial System Liquidity... The domestic equity market All-Share Index (ASI) gained by 0.12% to settle at 49,024.16 points as investors committed more funds to buy JAIZBANK (+8.43%) and FBNH (+2.00%) shares today. Other companies such as GUINNESS (+9.29%), CADBURY (+8.37), TRANSCORP (+6.80), and NGXGROUP (+2.56%) also enjoyed investors' patronage, hence making the number of gainers (17) stand above that of the losers (10) at the close of the trading session. Consequently, the year-to-date gain of the local bourse increased to 14.77%. The sub-sector gauges tracked were largely bullish as the NGX Banking, NGX Consumer Goods, and NGX Oil/Gas indexes increased by 0.41%, 0.57%, and 0.03%, respectively. On the flip side, NGX Insurance fell 0.09%, while the NGX Industrial index remained unchanged. Elsewhere, market activity expanded today, with total trades, volume, and value rising by 3.67%, 61.58%, and 65.96%, respectively, to 3,219 trades, 356.73 million units, and N3.74 billion. In terms of volume and turnover, GTCO was the most active stock, with 135.62 million shares worth N2.41 billion changing hands in 731 trades.



Money Market

As banks with liquidity sought higher rates, NIBOR increased across the board for all maturities tracked, despite the overnight lending rate and open buyback rate jumping 6 basis points and 3 basis points, respectively, to 15.50% and 16.00%.

Similarly, NITTY climbed across all tenor buckets tracked amid persistent sell pressure.

Bond Market

In the OTC bond market, the values of plain vanilla FGN bonds moderated for most maturities tracked.

On the flip side, the values of FGN Eurobonds appreciated for all maturities tracked amid renewed buy pressure.

Foreign Exchange Market

The Naira closed flat at N437.03 at the I&E windows. The parallel market rate, on the other hand, fell by 1.09%, from N740 to N732.

Global Oil Market

As of 4:00 p.m. GMT+1, Brent crude is down 0.41% to \$88.13 a barrel. Meanwhile, WTI crude oil fell 0.59% to \$80.75 per barrel.

Oil prices fell on Friday as negative sentiment continued to weigh on markets, with fears of a recession-like situation and a stronger dollar in the medium-term outweighing supply constraints.
