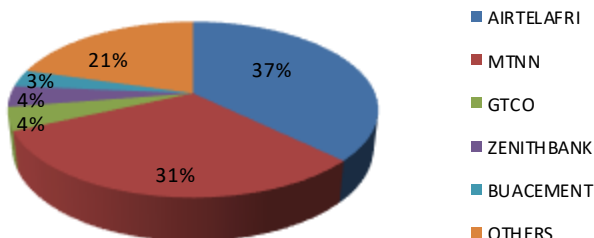

Domestic Equities Market Closes Higher by 0.73%; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Squeeze...

At the close of Tuesday's trading session, the domestic bourse extended its bullish streak as its All Share Index (ASI) rose by 0.73% to close at 44,788.14 points. However, the Exchange recorded 19 losers against 9 gainers even as positive sentiments dominated the market. Hence, the year-to-date gain of the NGX ASI climbed to 4.85%. Notably, today's bullish momentum was impacted by bargain-hunting activity in BUACEMENT (+10.00), JAIZBANK (+8.99%) UBN (+8.47%), and STERLNBANK (+2.63%) stocks. On the flip side, ROYALEX (-9.64%) led the laggards' chart, followed by MULTIVERSE (-8.50%), MAYBAKER (-6.67%), and CORNERST (-5.88%) accordingly. Sectorial performance was weak as three out of the five indices tracked closed in the red zone; the NGX Insurance, NGX Consumer Goods, and the NGX Oil/Gas indices declined by 0.24%, 0.09%, and 0.18%, respectively. On the positive side, the NGX Banking index and the NGX Industrial index rose by 0.49% and 4.01%, respectively. Elsewhere, market activity came in strong today, with total deals, volume, and value increasing by 17.25%, 120.12%, and 25.84%, respectively, to 3,385 trades, 159.21 million units, and N2.73 billion. In terms of volume, MBENEFIT was the most active stock, with 47.43 million shares worth N13.28 million changing hands in 12 deals.

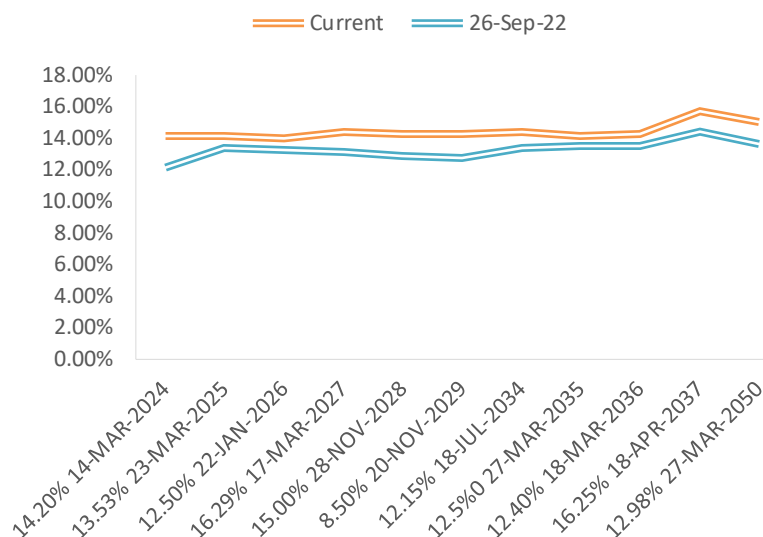

FGN BONDS YIELD



Money Market

NIBOR jumped across the board for the majority of maturities tracked as banks with liquidity demanded higher rates, despite the overnight lending rate and the open buyback rate concluding flat at 16.34% and 16.51%, respectively.

Similarly, NITTY increased across all tenor buckets tracked under sustained sell pressure.

Bond Market

In the OTC bond market, the values of plain vanilla FGN bonds remained unchanged for most maturities tracked as investors stayed on the sidelines.

On the flip side, the values of the FGN Eurobond rose for most maturities tracked amid sustained bullish sentiment.

Foreign Exchange Market

At the I&E windows, the Naira lost 0.07% against the US dollar, falling to N441.67 from N441.38. Likewise, the parallel market rate fell by 0.66% to N760 from N755.

Global Oil Market

As of 4:00 p.m. GMT+1, Brent crude is up 0.49% to \$93.72 a barrel. Similarly, WTI crude oil rose 1.46% to \$85.81 per barrel.

Oil prices rose on Tuesday, driven by a significant drop in the dollar and mounting supply concerns – as the EU ban on Russian crude draws nearer.
