

# Cowry Daily Market Insight 16 November 2022Q2 2022 Real GDP: 3.54%

Price Appreciations in ZENITH, GTCO, Others Lift NGX with N130bn Profit; NIBOR Down Across Board on System Liquidity Ease...

The bulls took rulership of the stock exchange market after two consecutive days of bearish outing which saw the NGX benchmark index advanced by 0.54% on Wednesday to 44,046.94 points and was buoyed by strong and sustained buying interests in banking, insurance and industrial goods stocks. As a result, the market capitalization gained N130.01 billion and advanced 0.54% to N23.99 trillion as the market YTD return inched higher to 3.12% despite the Exchange printing lower number of gainers (21) to decliners (24). Further afield, investors' sentiment grew positively towards some of the large and mid-cap tickers such as CORNERST (+10%), MRS (+9.73%), and ZENTHBANK (+8.46%), GTCO (+6.63%) and LAFARGE (5.97%). Across the sectors, market performance was largely positive with the NGX Banking, NGX Insurance and NGX Industrial Goods indices appreciating by 4.21%, 0.78% and 0.36% respectively. On the flip side, the NGX Consumer Goods and NGX Oil/Gas Indices tanked by 0.24% and 0.35% due to price declines in ETERNA (-10.0%), and GUINNESS (-9.98%). Meanwhile, market activity was upbeat as total volume and value traded surged by 54.10% and 141.12% to 159.44 million units and N2.86 billion respectively but the trades took a nosedive by marginal 0.20% to 3,039 deals. At the end of the session, FIDELITYBK was the most active stock by traded volumes reaching 27.95 million units worth N114 million changing hands in 110 deals while AIRTELAFRI led the chart for most value at N626.62 million.



### Money Market

NIBOR fell across the board for all maturities tracked as liquidity eased in the banking system, even as the Open Buyback Rate (OPR) rose 8bps to 16.25% and the Overnight Lending Rate (OVN stayed flat at 16.50% from the last close. Elsewhere, NITTY closed the day in a mixed bag across the board for tenor buckets monitored as we saw the short-tenor rates eased while the long tenors inched upward. Thus, the average yield in the T-bill secondary market declined (0.44 ppt) to 10.17% from yesterday's close of 10.61% due to demand for the 07-Sep-23 (-1.53ppt) and 26-Oct-23 T-bills (-1.97 ppt). However, there was sell-off on the 23-Feb-23 T-bills (+1.38 ppt).

#### **Bond Market**

In the OTC bond market, the values of plain vanilla FGN bonds closed bullish for the mid and long-dated debt instruments as investors erred cautiously. The average secondary market yield tanked marginally by 0.06 ppt to 14.42%. At the close of today, the 26-APR-2049 and 27-MAR-2050 instrument were the best performers (-0.22 ppt).

Meanwhile, the value of the FGN Eurobond closed lower for all maturities tracked on waning sentiment. Hence, the average yield was negative (-0.10 ppt) as it closed at 11.41%.

### Foreign Exchange Market

At the I&E windows, the Naira closed quietly on Wednesday against the US dollar at N446.67/USD from N446.67/USD on Tuesday. Similarly, at the parallel market, the Naira lost N18 (2.34%) to close atN799/USD from N781/USD as dollar scarcity bites harder on the back of short supply. Notably, currency traders kept offers for the greenback between N785 and N810.

#### Global Oil Market

As of 3:30 p.m. GMT+1, Brent crude is down 1.91% to \$92.06 a barrel. However, WTI crude oil followed same line and down 2.12% to \$85.08 per barre and almost more than 3-weeks low as investors fret over the news of covid resurgence in China which is likely to further dampen the demand outlook.
