

Domestic Bourse Kick-Starts Week on Bullish Momentum as ASI Increases by 0.47%; NIBOR Falls for most Tenor Buckets amid Liquidity Ease...

The domestic stock market kick-started the new trading week positively as the benchmark index gained 0.47% to conclude at 44,701.84 points, amid sustained bargain-hunting activity even as the Exchange printed more gainers (26) than losers (6) at the end of the trading session. Hence, the year-to-date gain of the NGX ASI rose to 4.65%. Specifically, tickers such as NB, BUAFOODS, ACCESSCORP, FBNH, and ZENITHBANK enjoyed investors' patronage as their respective share prices rose by 9.94%, 3.51%, 1.85%, 1.82%, and 1.64%, respectively. Sectorial performance was upbeat as four out of the five indices tracked closed in the green zone; the NGX Banking, NGX Insurance, NGX Consumer Goods, and the NGX Oil/Gas indices rose by 1.25%, 0.18%, 2.44%, and 0.15%, respectively. On the flip side, the NGX Industrial Index fell by 0.03%. Meanwhile, activity in the market improved further as total deals, volume, and value increased by 16.58%, 3.08%, and 53.31%, respectively, to 3,530 trades, 151.19 million units, and N1.89 billion. In terms of volume, TRANSCORP was the most active stock, with 35.24 million shares worth N39.40 million changing hands in 68 deals.



### Money Market

NIBOR decreased across the board for most maturities tracked as banks with liquidity requested lower rates, despite the Open Buyback Rate (OPR) and the Overnight Lending Rate (OVN) remaining unchanged at 16.25% and 16.50%, respectively. Elsewhere, NITTY increased across the board for the majority of the tenor buckets monitored. However, the average yield in the T-bill secondary market contracted by 0.01 percentage point to 10.61%.

### Bond Market

In the OTC bond market, the values of plain vanilla FGN bonds fell for most tenor buckets tracked. Similarly, the average secondary market yield contracted by 0.04 percentage points to 14.33% as investors played around the belly of the yield curve.

Meanwhile, the value of the FGN Eurobond decreased for all maturities tracked amid renewed bearish sentiment. Hence, the average yield expanded by 0.57 percentage points to 12.49%.

### Foreign Exchange Market

At the I&E windows, the Naira strengthened against the US dollar, gaining 0.07% to N445.38 from N445.67. Similarly, the Naira edged ahead of the dollar at the parallel market, climbing 0.51% from N784 to N780. Notably, currency traders maintained offers for the greenback between N760 and N785.

### Global Oil Market

As of 3:30 p.m. GMT+1, Brent crude is down 1.88% to \$85.97 a barrel. Similarly, WTI crude oil fell 2.18% to \$78.34 per barrel.

Oil prices fell on Monday amid a rising dollar and growing energy demand concerns that outweighed supply constraints in the near future.
