

Domestic Bourse Index Rises by 0.05% on ARDOVA, FBNH Shares; NIBOR Moves Southwards for Most Tenor Buckets on Liquidity Boost...

The local bourse index rose further by 5 basis points (bps) to close at 49,499.43 points as bullish momentum was sustained today, especially on the share prices of JBERGER (+9.91%), CHAMPION (+9.30%), ARDOVA (+9.20%), and FBNH (+4.05%). Given the usual bullish activity in the equity market in Q4, the number of gainers (17) continues to outshine that of the losers (15). Hence, the year-to-date gain of the local bourse advanced to 15.88%. Positive sectoral performance was skewed towards the NGX Consumer Goods and the NGX Oil/Gas as their indices rose by 0.04% and 0.26%, respectively. However, the NGX Banking, NGX Insurance, and NGX Industrial indices fell by 0.11%, 0.31%, and 0.21%, respectively. Meanwhile, trading activity was downbeat, as total volume, and value mellowed by 67.76%, and 50.47%, respectively, to 132.57 million units and N3.14 billion. In terms of volume. FBNH was the most active stock, with 29.10 million shares worth N331.22 million changing hands in 166 deals.



## Money Market

NIBOR fell across the board for the majority of maturities tracked as banks with liquidity sought lower rates. Specifically, short-term benchmark rates, such as the Open Repo Rate (OPR) and the Overnight Lending Rate (OVN), narrowed to 9.50% (up from 10.25%) and 10.13% (up from 10.63%), respectively.

Meanwhile, NITTY rose across the board for all tenor buckets tracked, despite the average secondary market T-bill yield falling to 5.41% due to demand pressure in short-term maturities, particularly 26 Jan 2023 (-1.00 ppt), 09 Feb 2023 (-0.94 ppt), and 09 Mar 2023 (-1.10 ppt).

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained relatively flat for the bulk of maturities examined, despite the average secondary market contracting 6 bps to 13.21%. Notably, the yields on the 15-year and the 20-year debt decreased to 13.20% (from 13.93%) and 14.35% (from 14.37%) on sustained buy interest. Meanwhile, the yields on the 10-year and 30-year bonds were unchanged from the previous trading day at 13.94%, and 14.00%, respectively.

Elsewhere, the value of the FGN Eurobond increased for all of the maturities tracked due to sustained bullish sentiment. Consequently, the average yield crashed by 18bps to 11.84%.

## Foreign Exchange Market

At the I&E windows, the Naira rebounded from yesterday's slump as it appreciated from N456.33 to N456.25 against the US dollar. Likewise, the parallel market rate gained 0.67% to N742 from N747.

## Global Oil Market

As of 3:30 p.m. GMT+1, Brent crude is up by 1.19% to \$83.18 a barrel. Similarly, WTI crude oil rose 1.03% to \$79.10 per barrel.

Oil futures rose further on Thursday as traders anticipated tighter US supplies throughout the high-demand holiday and travel season.
