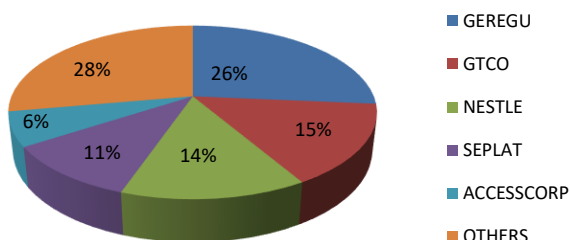

Equities Market Index Advances by 0.46% amid Sustained Bullish Activity; NIBOR Rises for All Tenor Bucket amid Financial Liquidity Squeeze...

The local Bourse ASI resumed the week in positive territory as it ballooned by 0.46% to close at 49,934.60 points amid sustained bargain-hunting activity even as the Exchange printed more gainers (27) than losers (6) at the close of the trading session. Consequently, the year-to-date gain of the NGX ASI climbed to 16.90%. Specifically, tickers such as CHAMPION, GEREGU, WEMABANK, GTCO, and PRESCO enjoyed investors' patronage as their respective share prices increased by 10.00%, 9.96%, 9.94%, 3.79%, and 3.73%. Of the five indices tracked, three closed in the green zone while others stayed flat; the NGX Banking, NGX Insurance, and NGX Consumer Goods indices rose by 1.38%, 1.37%, and 1.07%, respectively. On the flip side, the NGX Oil/Gas and the NGX Industrial indices remained unchanged from the previous day. Meanwhile, trading activity was upbeat as the total deals and volume rose by 93.36%, and 255.30%, respectively, to 3,989 trades and N498.73 million units. In terms of volume. VERITASKAP was the most active stock, with 69.71 million shares worth N348.54 million changing hands in 24 deals.

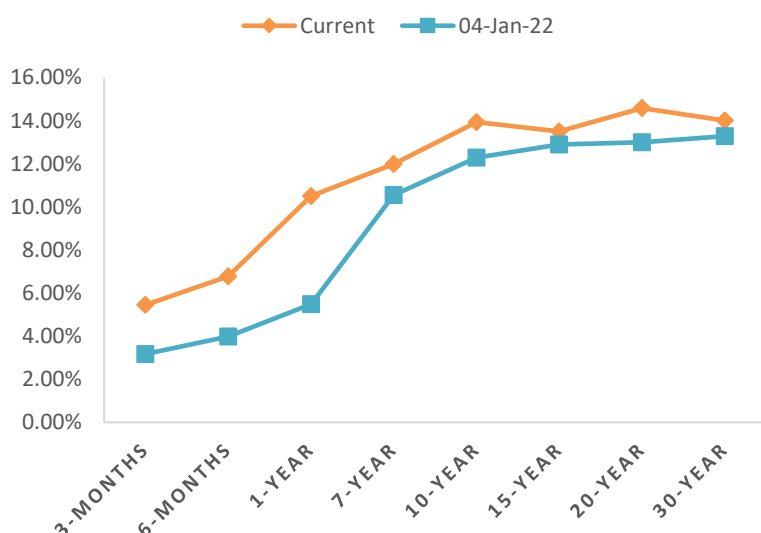

## Money Market

NIBOR rose across the board for all of the maturities tracked as banks with liquidity sought higher rates. However, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), narrowed to 10.75% (down from 12.00%) and 10.83% (down from 12.75%), respectively.

Meanwhile, NITTY fell across the board for all tenor buckets tracked, despite the average secondary market T-bill yield rising to 5.46% amid sell pressure, particularly on the 09 Mar 2023 T-bill.

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained relatively flat for the bulk of maturities examined, despite the average secondary market contracting further by 2 bps to 13.05%. Notably, the yield on the 20-year debt increased to 14.58% (from 14.52%) amid renewed bearish activity. Meanwhile, the yields on the 10-year, 15-year, and 30-year bonds were unchanged from the previous trading day at 13.93%, 13.50%, and 14.00%, respectively.

Elsewhere, the value of the FGN Eurobond decreased for all of the maturities tracked due to sell-offs across the curve. Consequently, the average yield rose by 10 bps to 11.93%.

## Foreign Exchange Market

At the I&E windows, the Naira depreciated further to ₦461.33 from ₦456.50 against the US dollar. Conversely, the parallel market rate gained 0.40% to ₦738 from ₦741.

## Global Oil Market

As of 3:30 p.m. GMT+1, Brent crude is down by 1.18% to \$83.34 a barrel. Similarly, WTI crude oil fell 1.38% to \$78.44 per barrel.

Oil futures fell on Monday as traders assessed the impacts of recent COVID-19 case surges in China, the world's top oil importer.
