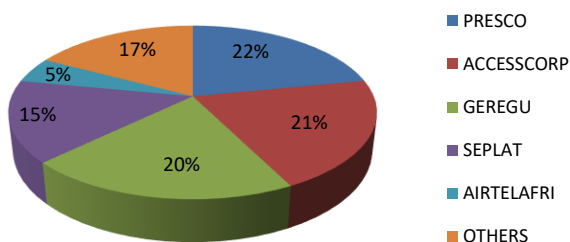

Nigerian Stock Market Index Up by 1.89% on the Last Trading Day of 2022; NIBOR, NITTY Fall for all Tenor Buckets amid Sustained Liquidity Ease...

The domestic equities market ended the year on a high note, with the All-Share Index (ASI) soaring 1.89% to 51,251.06 points, as investors poured money into PRESCO (+10.00), AIRTELAFRI (+9.88%), and GEREGU (+6.66%). Hence, the year-to-date gain of the NGX ASI advanced to 19.98% even as the Exchange printed more gainers (27) than losers (17) today. Notably, tickers such as FCMB (+8.76), WEMABANK (+8.33), CHAMPION (+6.38%), NAHCO (+1.59%), and UCAP (+0.72%) also enjoyed investors' patronage. Meanwhile, sell-offs in Tier-1 banks such as ZENITHBANK (-3.61%), UBA (-3.18%), ACCESSCORP (-2.30%), and GTCO (-1.71%) limited the NGX ASI gains today, resulting in a 2.86% drop in the NGX Banking index. Likewise, the NGX Oil/Gas index declined 0.41%, driven by losses in ARDOVA (-2.13%) and OANDO (-1.75%). Notably, the NGX Insurance and NGX Consumer Goods indexes rose 0.40% and 0.09%, respectively, while the NGX Industrial index remained flat from the previous day. Meanwhile, trading activity remained subdued, with the total number of transactions and their value falling by 20.40% and 5.06%, respectively, to 3,566 trades and \$ 7.36 billion. In terms of volume. SOVRENINS was the most active stock, with 146.70 million shares worth N523.93 million changing hands in 3 deals.

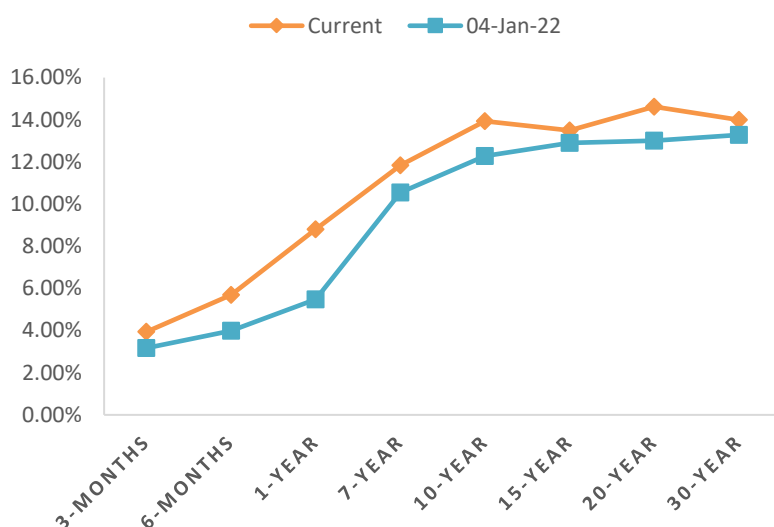

## Money Market

NIBOR declined across the board for all maturities tracked as banks with liquidity sought lower rates. However, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), widened to 11.75% (down from 9.50%) and 11.33% (down from 9.83%), respectively.

Meanwhile, NITTY fell across the board for all tenor buckets tracked, despite the average secondary market T-bill yield staying unchanged at 5.38%.

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained flat for all of the maturities monitored. Consequently, the average secondary market remained unchanged from the previous day at 13.04%. Meanwhile, the yields on the 10-year, 15-year, 20-year, and 30-year bonds were unchanged from the previous trading day at 13.93%, 13.50%, 14.62%, and 14.00%, respectively.

Elsewhere, the value of the FGN Eurobond decreased for most of the maturities tracked due to renewed bearish activity. In contrast, the average secondary market yield decreased marginally by 1 bps to 11.90% amid strong demand at the short end of the curve.

## Foreign Exchange Market

The Naira appreciated against the US dollar at the I&E windows, rising 0.04% to ₦461.50 (from ₦461.67). Furthermore, the parallel market rate gained 0.67% to ₦737 from ₦742.

## Global Oil Market

As of 3:30 p.m. GMT+1, Brent crude is up by 0.68% to \$84.03 a barrel. Similarly, WTI crude oil rose 0.67% to \$78.93 per barrel.

Oil prices rebounded on Friday amid a weakening dollar and growing supply constraints that outweighed demand concerns. Notably, Brent is set for an 8.00% annual gain.
