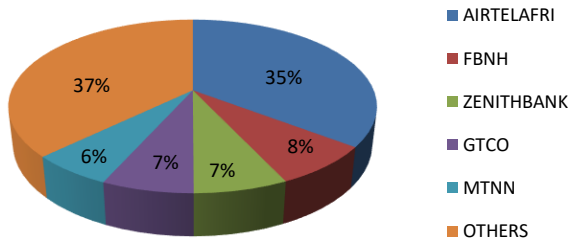

Domestic Bourse Begins Week on Bullish Momentum as ASI Increases by 0.93%; NITTY Rises for most Tenor Buckets on Sell Pressure...

The local bourse resumed the week on a positive note as its All Share Index (ASI) advanced by 0.93% to close at 51,700.36 points (the highest since July 25, 2022). Consequently, the year-to-date gain of the NGX ASI rebounded to 0.88% even as the exchange recorded 18 gainers as opposed to 16 losers. Sectorial performance was a mixed bag as the NGX Banking and the NGX Insurance indices fell by 1.31% and 0.70%, respectively, while the NGX Oil/Gas and the NGX Industrial indices stayed flat from the previous trading day. The NGX Consumer Goods Index rose by 0.19%. Meanwhile, trading activity remained upbeat, with total deals and volume increasing by 6.85%, and 17.10%, respectively, to 3,900 trades, and 229.22 million units. In terms of volume, STERLNBANK was the most active stock, with 85.18 million shares worth N119.25 million changing hands in 76 deals.

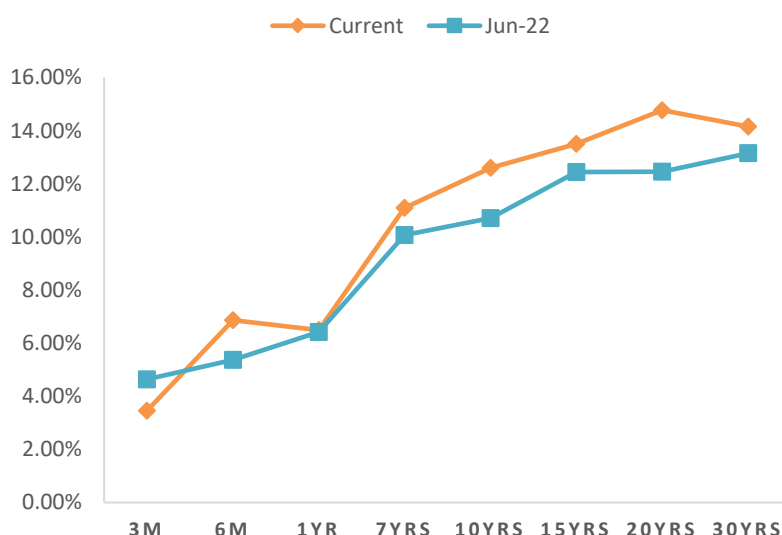

Money Market

NIBOR moved in mixed directions, although short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), decreased to 10.17% and 10.83%, respectively.

Meanwhile, NITTY rose across the board for all of the tenor buckets tracked, even as the average secondary market T-bill yield fell to 3.05% amid sell pressure across the short side of the curve.

Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained relatively stable for most maturities monitored. In contrast, the average secondary market yield rose by 3 bps to 12.71%. Specifically, the yield on 20-year paper increased by 143 bps (1.43%) to 14.77%. Meanwhile, the yields on the 10-year, 15-year, and 30-year bonds stayed steady at 12.59%, 13.50%, and 14.15%, respectively.

Elsewhere, the value of the FGN Eurobond increased for the bulk of the maturities tracked amid renewed bullish sentiment. Consequently, the average secondary market yield plunged by 49 bps to 10.99%.

Foreign Exchange Market

In FX, the Naira remained unchanged against the greenback exchanging at N437.03 at the I&E windows. However, the parallel market rate fell by 0.13% to N743 from N742.

Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is up 2.51% to \$80.54 a barrel. Similarly, WTI crude oil rose 2.40% to \$75.54 per barrel.

Oil prices jumped on Monday, boosted by improved energy demand as China reopened its borders.

Spot gold was trading near \$1875 per ounce, close to an eight-month high, as the dollar fell, oil prices rose, and the US services sector unexpectedly shrank.
