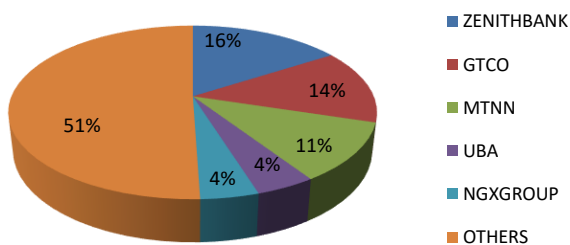

NGX ASI Falls by 0.31% amid Renewed Bearish Activity; NIBOR Rises for most Tenor Buckets on Liquidity Squeeze...

The local stock market began the trading week in the negative zone, with the All-Share Index (ASI) falling 0.31% to 52,348.82 points, driven down by sell-offs in banking shares. Hence, the year-to-date gain of the NGX ASI lowered to 2.14% even as the exchange recorded a higher number of losers (23) than gainers (20). Notably, investors sold off part of their holdings in bellwethers like UBA (-4.19%), ACCESSCORP (-3.76%) ZENITHBANK (-3.72%), WAPCO (-3.56%), GTCO (-1.63%), and NB (-1.17%). Sectorial performance was weak as three of the five indices tracked closed in red. The NGX Consumer Goods index, in particular, declined by 0.08%, despite data from the NBS indicating Nigeria's consumer price inflation eased to 21.34% in December (from 21.47% in November). Similarly, the NGX Banking, and the NGX Industrial Indices fell by 3.39%, and 0.18%, respectively. On the flip side, the NGX Insurance index and the NGX Oil/Gas Index rose by 0.39% and 0.09%. In the broader market, NGX Premium and NGX-30 lost 0.58% and 0.30%, respectively. Meanwhile, trading activity was upbeat, with total deals, volume, and value increasing by 13.68%, 2.16%, and 27.34%, respectively, to 5,219 trades, 217.16 million units, and N3.25 billion. In terms of volume, UBA was the most active stock, with 22.93 million shares worth N185.90 million changing hands in 257 deals.

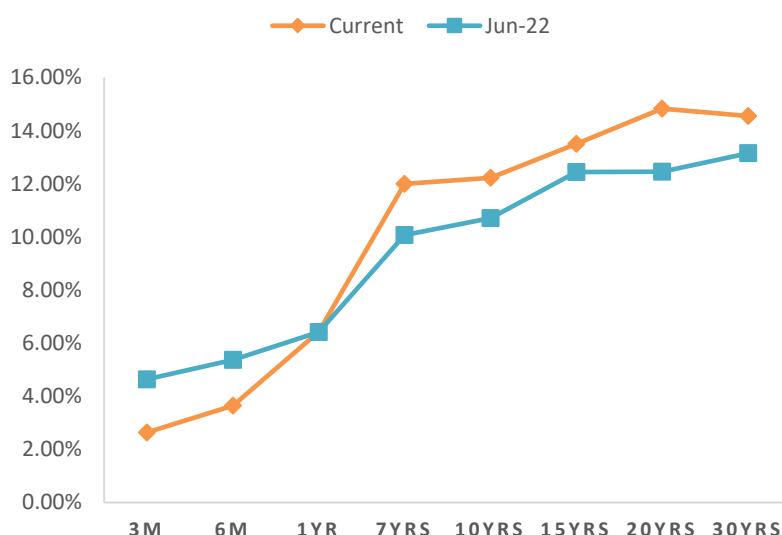

Money Market

On Monday, NIBOR climbed across the board for most maturities tracked, likewise other measures of money market stress tightened, as banks with liquidity sought higher rates. However, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), remained stable at 9.67% and 10.00%, respectively.

Meanwhile, NITTY fell for the majority of tenor buckets tracked, despite the average secondary market yield on T-bills contracting to 3.27%, due to sell pressure on mid- and long-dated securities.

Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained largely flat for most maturities monitored. In contrast, the average secondary market yield expanded by 3 basis points to 12.81%. Specifically, the yield on the 20-year debt compressed by 65 bps (0.65%) to 14.83%. Meanwhile, the yields on the 10-year, 15-year, and 30-year bonds stayed steady at 12.24%, 13.50%, and 14.55%, respectively.

Elsewhere, the value of the FGN Eurobond increased for most of the maturities tracked amid sustained bullish sentiment. Consequently, the average secondary market yield contracted marginally by 3 bps to 10.30%.

Foreign Exchange Market

In FX, the Naira appreciated against the US dollar at the I&E windows, rising 0.09% to ₦461.50 (from ₦461.90). Likewise, the parallel market rate gained 0.27% to ₦743 from ₦745.

Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is down 1.17% to \$84.29 a barrel. Similarly, WTI crude oil fell 1.15% to \$78.95 per barrel.

Oil futures traded lower on Monday as investors weighed the risks of a global economic recession against the impact of China's reopening on the global energy demand outlook.

Spot gold fell roughly \$0.32 to trade around \$1910 per ounce amid a US dollar recovery.
