Equities Market Index Falls by 0.06% on NESTLE, GTCO; NIBOR Rises for All Tenor Buckets on Liquidity Squeeze...

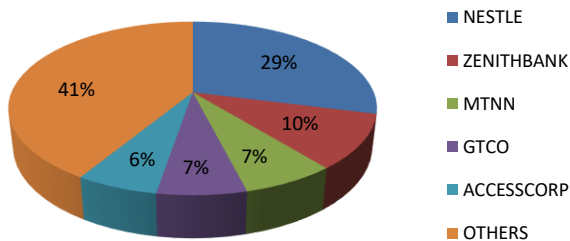
The local bourse closed the trading week southward as its index declined by 6 basis points (0.06%) to close at 52,594.68 points; although the number of gainers (15) outweighed that of the losers (13). Furthermore, with investors' appetite for risk weakening compared to the first half of January, the NGX ASI's year-to-date gain fell to 2.62%. Specifically, the NGX Consumer Goods index closed in red, following sell pressure on tickers such as DANGSUGAR (-2.58%), PZ (-1.94%), and NESTLE (-1.81%). Performance across the sub-indices tracked was largely negative, as three of the five sub-sector gauges closed in the red. The NGX Insurance index, the NGX Consumer Goods index, and the NGX Industrial index dipped by 0.25%, 0.62%, and 0.03%, respectively. On the flip side, the NGX Banking Index rose by 0.37%, while the NGX Oil/Gas Index remained flat. In the broader market, NGX Premium rose further by 1 bps, while the NGX-30 fell by 6 bps. Meanwhile, trading activity was downbeat, with total deals and value decreasing by 2.61%, and 7.42%, respectively, to 3,100 trades and N1.68 billion. In terms of volume, VERITASKAP was the most active stock, with 347.05 million shares worth N69.41 million changing hands in 11 deals

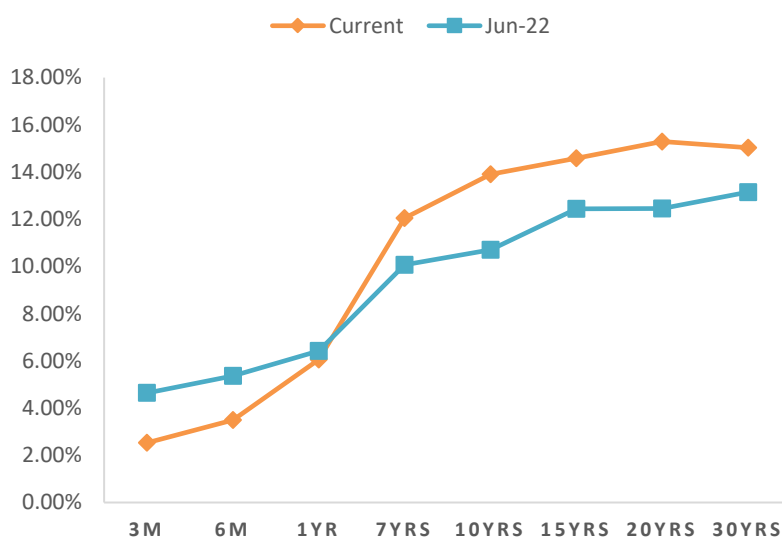

Money Market

NIBOR rose across the board for all maturities tracked, likewise, other measures of money market stress tightened, as banks with liquidity sought higher rates. Likewise, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), climbed to 11.00% (up from 9.50%) and 11.50% (up from 9.83%), respectively.

Meanwhile, NITTY decreased for all of the tenor buckets tracked, despite the average secondary market yield on T-bills staying steady at 3.47% from the previous day.

Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained largely flat for most maturities monitored. In contrast, the average secondary market yield expanded by 2 basis points to 13.42%. Specifically, the yield on the 30-year paper increased by 85 bps (0.85%) to 15.03%. Meanwhile, the yields on the 10-year, 15-year, and 20-year bonds stayed steady at 13.90%, 14.58%, and 15.29%, respectively.

Elsewhere, the value of the FGN Eurobond increased for most of the maturities tracked amid renewed bullish activity. Consequently, the average secondary market yield contracted by 8 bps to 10.30%.

Foreign Exchange Market

In FX, the Naira remained unchanged against the greenback, exchanging at N461.50 at the I&E windows. However, the parallel market depreciated by 0.54% to N750 from N746.

Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is up 0.23% to \$86.36 a barrel. Similarly, WTI crude oil rose 0.27% to \$80.83 per barrel.

Oil futures were higher on Friday, on track for a second consecutive weekly gain, as investors remained bullish on China's economic and energy demand prospects.

Spot gold consolidated around \$1923 per ounce, limited by an uptick in US treasuries, despite a weak US dollar. Notably, gold prices were set to gain for the fifth straight week.
