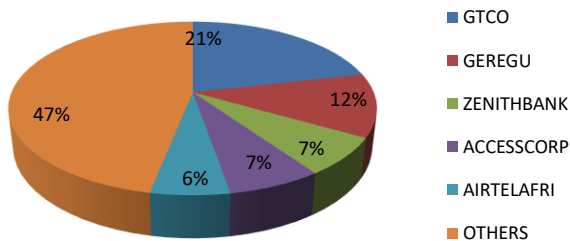

Domestic Bourse All-Share Index Gains 0.29% on GREGU, TOTAL Shares; NITTY Falls for All Tenor Buckets on Buy Pressure...

The Local bourse index rose by 0.29% with a gain of 2.90% year-to-date to close at 52,752.96 points, even as the exchange printed a higher number of gainers (25) than losers (7). GREGU gained 10.00% to lead the best-performing five stocks in the session. Also, FIDELITYBK (+5.75%), TOTAL (+5.51%), ACCESSCORP (4.44%), ZENITHBANK (+0.82%), UNILEVER (+0.38%), and NB (+0.24%) closed positive, while RTBRISCOE (-9.09%), TRANSCORP (-0.82%), DANGSUGAR (-0.59%), and WAPCO (-0.05%) closed negative. Sectorial performance was strong as four of the five indices tracked closed in the green; the NGX Banking, NGX Insurance, NGX Consumer Goods, and NGX Oil/Gas indices climbed by 1.58%, 1.01%, 0.05%, and 1.58%, respectively. On the flip side, the NGX Industrial Index fell marginally by 0.01%. In the broader market, the NGX Premium index and the NGX-30 index advanced by 19 bps and 15 bps respectively. Meanwhile, trading activity was downbeat, with total deals and value decreasing by 0.08%, and 24.84%, respectively, to 3,549 trades and N2.02 billion. In terms of volume, GTCO was the most active stock, with 17.79 million shares worth N433.18 million changing hands in 216 deals.

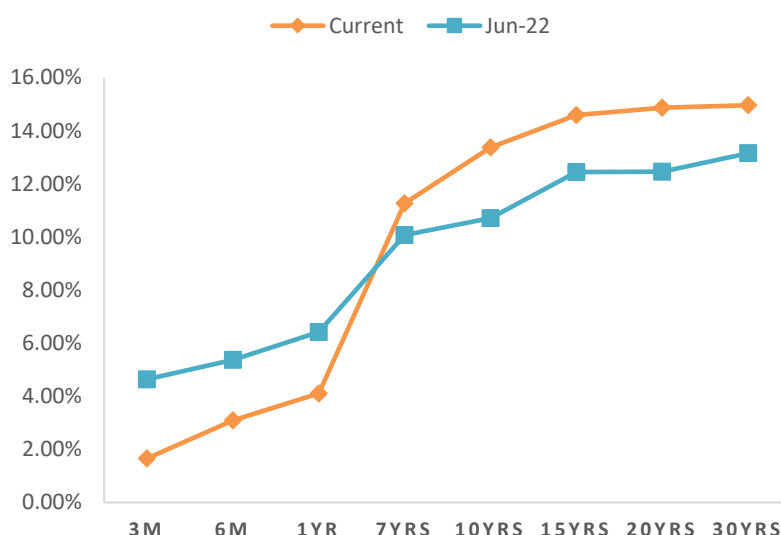

## Money Market

N NIBOR moved in mixed directions. Meanwhile, short-term benchmark rates, such as the overnight lending rate (OVN), widened to 11.00% (up from 10.83%), while the open repo rate (OPR) remained unchanged at 10.50%.

Meanwhile, NITTY decreased for all of the tenor buckets tracked, even as the average secondary market yield on T-bills contracted to 1.47% amid sustained demand pressure across the curve.

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained relatively flat for most maturities monitored. However, the average secondary market yield compressed by 13 basis points to 13.22%. Notably, the 20-year paper was richer by 305 basis points at 14.87%. Meanwhile, the yields on the 10-year, 15-year, and 30-year bonds stayed steady at 13.37%, 14.58%, and 14.96%, respectively.

Elsewhere, the value of the FGN Eurobond decreased for most of the maturities tracked amid renewed bearish sentiment. Notably, the average secondary market yield increased to 10.77%.

## Foreign Exchange Market

In FX, the Naira strengthened against the greenback, trading at N461.7 at the I&E windows. In contrast, the parallel market depreciated by 0.13% to N750 from N749.

## Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is up 2.21% to \$88.03 a barrel. Conversely, WTI crude oil rose 2.47% to \$82.13 per barrel.

Oil futures gained on Tuesday, bolstered by a smaller-than-expected increase in US oil stocks and robust confidence about global energy demand.

Spot gold was trading around \$1938 per ounce (down 0.38%), capped by an uptick in the US dollar and Treasury bonds.
