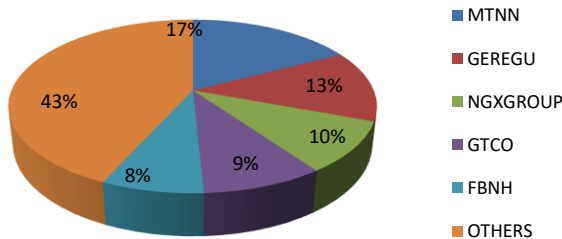

## Local Equities Market Closes Negative as NGX ASI Falls by 0.18%; NIBOR Rises for all Tenor Buckets as Financial Liquidity Tightens...

At the close of Friday's trade, the local equity market index fell by 0.18% to settle at 52,657.88 points as investors booked profits. Hence, the year-to-date gain of the local bourse declined to 2.75%, despite the exchange recording more gainers (24) than losers (11). Specifically, counters such as INTBREW, ACCESSCORP, GUINNESS, CADBURY, and MTNN decreased by 6.12%, 4.26%, 3.71%, 2.53%, and 1.75%, respectively. Sectorial performance was positive as three of the five indices tracked closed northward: the NGX Insurance, NGX Oil/Gas, and NGX Industrial indices rose by 0.36%, 0.13%, and 0.01%, respectively. On the flip side, the NGX Banking and NGX Consumer Goods indices fell by 0.03% and 0.39%, respectively. In the broader market, the NGX Premium index and the NGX-30 index declined by 76 bps and 34 bps respectively. Meanwhile, trading activity was upbeat, with total deals, volume, and value increasing by 1.41%, 22.50%, and 15.93%, respectively, to 3,599 trades, 171.11 million units, and N2.32 billion. In terms of volume, FIDELITYBK was the most active stock, with 26.64 million shares worth N145.13 million changing hands in 270 deals.

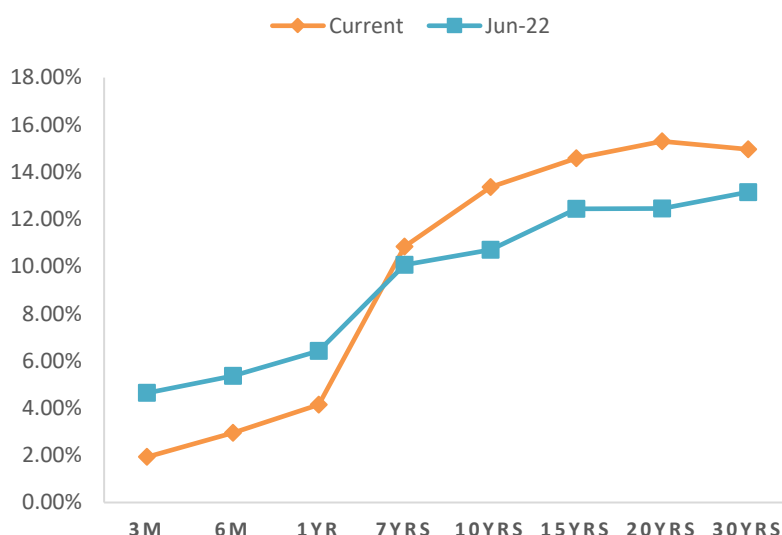

## Money Market

NIBOR rose across the board for all maturities tracked, as gauges of money market stress tightened, and banks with liquidity sought higher rates. Short-term benchmark rates, on the other hand, such as the open repo rate (OPR) and the overnight lending rate (OVN), stayed stable at 10.50% and 11.00%, respectively.

Meanwhile, NITTY increased for most of the tenor buckets tracked, despite the average secondary market yield on T-bills remaining unchanged at 1.47%.

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained largely flat for most maturities monitored. However, the average secondary market yield contracted by 11 basis points to 13.11%. Notably, the 20-year paper was cheaper by 289 basis points to 15.30% (from 14.87%). Meanwhile, the yields on the 10-year, 15-year, and 30-year debts stayed steady at 13.37%, 14.58%, and 14.96%, respectively.

Elsewhere, the value of the FGN Eurobond decreased for most of the maturities tracked amid sustained bearish sentiment. Notably, the average secondary market yield increased to 10.78%.

## Foreign Exchange Market

In the I&E windows, the Naira weakened against the greenback, trading at ₦461.75. In contrast, the parallel market appreciated by 0.53% to ₦748 from ₦750.

## Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is up 0.84% to \$88.20 a barrel. Similarly, WTI crude oil rose 0.81% to \$81.67 per barrel.

Oil futures were higher on Friday, lifted by strong optimism about global energy demand as well as a better-than-expected US Q4 GDP report, which boosted market expectations of a soft landing.

Spot gold was trading around \$1923 per ounce (down 0.29%), constrained by an uptick in the US dollar.
