



NGX All-Share Index Rises by 3bps amid Sustained Bargain Hunting; NIBOR Closes Higher for All Maturities Tracked on Liquidity Squeeze...

The local stock market All-Share Index rose further by 0.03% to 54,521.49 points amid sustained bullish sentiment on small stocks such as TRIPPLEG (+9.70%), LIVINGTRUST (+6.90%), and IKEJAHOTEL (+2.88%). Consequently, the year-to-date gain of the local bourse advanced to 6.38% even as the total number of gainers reduced to 17 (from 20), albeit it still outweighed that of the losers (14). The sector gauges performed poorly, with four of the five sub-indices closing in the red: the NGX Banking, NGX Insurance, NGX Oil/Gas, and NGX Industrial indices fell by 0.01%, 0.41%, 0.02%, and 0.13%, respectively. However, the NGX Consumer Goods index fell by 0.14%. In the broader market, the NGX Premium and the NGX-30 index decreased by 6 basis points and 7 basis points, respectively. Meanwhile, trading activity decreased, with total deals, volume, and value falling by 8.09%, 6.40%, and 17.28%, respectively, to 2,670 trades, 125.86 million units, and N3.6 billion. In terms of volume, GTCO was the most active stock, with 19.17 million shares worth N481.72 million changing hands in 175 deals.



Money Market

NIBOR jumped across the board for all maturities tracked, as gauges of money market stress tightened further and banks with liquidity requested high rates. However, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), declined to 15.38% (from 16.13%) and 16.25% (from 16.63%), respectively.

Meanwhile, NITTY climbed across the board for the bulk of tenor buckets monitored, even as the average secondary market yield on T-bills expanded to 3.80% due to demand pressure on the 9 Mar 2023 and 13 Apr 2023 T-bills.

Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds remained relatively flat for the majority of the maturities examined. However, the average secondary market yield contracted by 1 basis point to 13.24%. The 20-year debt was 5 basis points richer, while its corresponding yield fell to 15.84% (from 15.89%). Notably, 10-year, 15-year, and 30-year paper yields remained constant at 13.20%, 14.80%, and 15.26%, respectively.

Elsewhere, the value of the FGN Eurobond increased for most of the maturities amid sustained bullish sentiment. Notably, the average secondary market yield contracted to 12.10%.

Foreign Exchange Market

The Naira weakened against the greenback, exchanging at N462 at the I&E windows. Similarly, the parallel market depreciated by 0.53% to N764 from N760.

Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is down 0.06% to \$84.74 a barrel. Conversely, WTI crude rose 0.09% to \$78.66 per barrel.

Oil futures fell on Thursday, driven by weakening demand in the US.

Gold was trading around \$1830 per ounce (down 0.28%) amid an uptick in the US dollar and treasuries.
