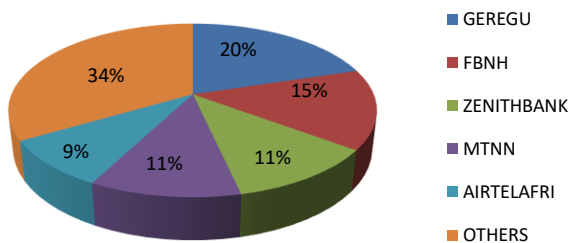

## Equity Market Closed the Week Negative as NGX-ASI Declines by 1.31%; NIBOR Rises for All Tenor Buckets on Liquidity Strain...

The Domestic bourse ended the day in negative territory as its All Share Index (ASI) moderated by 1.31% to close at 53,804.46 points amid a sell-off in AIRTELAFRI shares (-6.02%). As a result, the NGX ASI's year-to-date gain fell to 4.98%, even as the Exchange recorded more losers (18) than gainers (13). Notably, investors also sold off part of their holdings in blue-chip stocks like ZENITHBANK, WAPCO, UBA, ACCESSCORP, and GTCO; hence, their respective share prices declined by 1.96%, 0.96%, 0.60%, 0.05%, and 0.20%. Sectorial performance was mixed, with the NGX Banking and NGX Industrial Indices declining by 1.27% and 0.05%, respectively; while the NGX Insurance and NGX Consumer Goods Indices rose by 0.48% and 0.13%, respectively. The NGX Oil/Gas index stayed flat from the previous trading day. In the broader market, the NGX Premium and the NGX-30 index decreased by 18 basis points and 129 basis points, respectively. Meanwhile, trading activity increased, with total deals, volume, and value rising by 15.24%, 37.38%, and 4.52%, respectively, to 3,077 trades, 172.90 million units, and N3.77 billion. In terms of volume, FBNH was the most active stock, with 47.42 million shares worth N561.23 million changing hands in 98 deals.

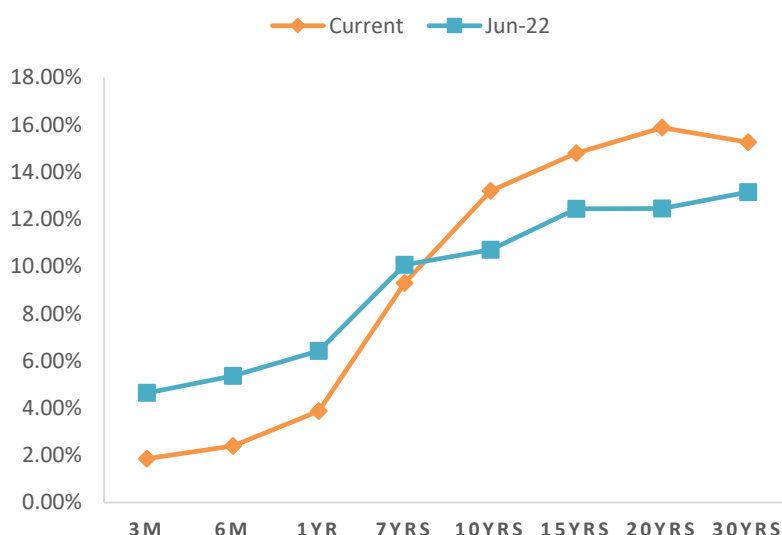

## Money Market

NIBOR jumped across the board for all maturities tracked, as gauges of money market stress tightened further and banks with liquidity sought high rates. Likewise, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), climbed to 17.13% (from 15.38%) and 17.81% (from 16.25%), respectively.

Meanwhile, NITTY rose across the board for all of the tenor buckets monitored, despite the average secondary market yield on T-bills staying unchanged.

## Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds fell for the majority of the maturities examined. Consequently, the average secondary market yield expanded by 2 basis points to 13.26%. The 20-year debt was 4 basis points cheaper, while its corresponding yield rose to 15.88% (from 15.84%). Notably, 10-year, 15-year, and 30-year paper yields remained stable at 13.20%, 14.80%, and 15.26%, respectively.

Elsewhere, the value of the FGN Eurobond decreased for most of the maturities amid renewed bearish sentiment. Notably, the average secondary market yield increased to 12.34%.

## Foreign Exchange Market

The Naira strengthened against the greenback, exchanging at N461.25 (from N462) at the I&E windows. Similarly, the parallel market depreciated by 0.26% to N766 from N764.

## Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is down 3.62% to \$82.34 a barrel. Similarly, WTI crude fell 3.30% to \$75.65 per barrel.

Oil futures fell on Friday, amid concerns of a global economic downturn fueled by weakening energy demand in the US and strong expectations for further policy rate hikes.

Gold was trading around \$1827 per ounce (down 0.52%) amid an uptick in the US dollar, a rise in US PPI for January, and hawkish remarks from US Federal Reserve officials.
