NGX ASI Rises by 0.69% amid Sustained Bullish Trend on Oil and Gas, Consumer Goods Stocks; NIBOR Rises for Most Tenor Buckets on Liquidity Squeeze...

The local bourse rose further by 0.69% to close at 55,328.42 points amid sustained bargain hunting activity as investors await the presidential result with optimism. Consequently, the NGX ASI's year-to-date gain jumped to 7.96% even as the exchange printed more gainers (28) than losers (9). Notably, oil/gas and consumer goods stocks enjoyed investors' patronage today, especially shares of OANDO (+10.00%), STANBIC (+10.00%), CONOIL (+9.98%), MRS (+9.66%), FLOURMILL (+9.05%), GEREGU (+5.69%), BUAFOODS (+4.65%), and ETERNA (2.19%). Given the bullish sentiment, performance across sub-indices tracked was positive, with the NGX Banking, NGX Insurance, NGX Consumer Goods, NGX Oil/Gas, and the NGX Industrial indices climbing by 0.48%, 1.07%, 2.39%, 1.42%, and 0.08%, respectively. In the broader market, the NGX Premium and the NGX-30 index increased by 15 basis points and 54 basis points, respectively. Meanwhile, trading activity increased, with total deals and volume rising by 12.98% and 25.77%, respectively, to 3,186 trades and 149.78 million units. In terms of volume, OANDO was the most active stock, with 14.29 million shares worth N62.64 million changing hands in 160 deals.



Money Market

NIBOR rose across the board for most maturities tracked, as gauges of money market stress tightened and banks with liquidity sought higher rates. However, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), stayed stable at 10.50% and 10.81%, respectively.

Meanwhile, NITTY rose across the board for all tenor buckets tracked, even as the average secondary market yield on T-bills increased to 4.04% due to sell pressure on the Mar 16 2023 T-bill.

Bond Market

In the OTC bond market, the prices of plain vanilla FGN bonds were largely flat for the majority of the maturities examined. However, the average secondary market yield expanded to 13.27% amid sell-offs across the front end and the belly of the yield curve. Notably, 10-year, 15-year, 20-year, and 30-year bond yields remained flat at 13.04%, 14.80%, 15.81%, and 15.20%, respectively.

Elsewhere, the value of the FGN Eurobond increased for all of the maturities amid sustained bullish sentiment. Notably, the average secondary market yield contracted to 11.07%.

Foreign Exchange Market

The Naira weakened against the greenback, exchanging at N462 (from N461.17) at the I&E windows. However, the parallel market appreciated by 0.26% to N760 from N762.

Global Commodity Market

As of 3:30 p.m. GMT+1, Brent crude is down 0.47% to \$82.77 a barrel. Similarly, WTI crude fell 0.30% to \$74.48 per barrel.

On Monday, oil futures fell as rising US crude stockpiles and broadbased hawkish rate expectations weighed on the market.

Gold was trading around \$1816 per ounce (up +0.31%), driven by a decline in the 10-year Treasury bond yield amid mixed US manufacturing data.
