

Equities Market Index Gains 0.27% amid Sustained Bullish Activity; NITTY Declines for All Tenor Buckets amid Sell Pressure...

The domestic stock market index advanced by 0.27% to close at 52,235.88 points amid sustained bullish activity, even as the exchange recorded more gainers (26) than losers (18) at the close of the trading session. Hence, the year-to-date gain of the NGX ASI rose to 1.92%. Disappointing earnings hit the shares of large-cap brewer, NB (-10.00%) after it reported a fall in production volume and sales revenue amid inflationary pressure, cash crunch challenges, and a high-interest rate environment. Fellow brewer INTBREW lost 2.4% to N4.70; likewise, major lenders ACCESSCORP (-3.38%), UBA (-0.63%), and GTCO (-0.40%) also closed lower today. However, these losses were offset by a slew of upbeat corporate earnings from consumer goods stocks, such as CADBURY (+9.82%), BUAFOODS (+5.88%), and NASCON (+2.14%), as they enjoyed strong investors' patronage. Conglomerate, TRANSCORP gained 5.76% amid reports of a 25.58% share acquisition by HH Capital. Sectorial performance was positive, as three of the five indices tracked closed in the green zone: the NGX Insurance, NGX Consumer Goods, and NGX Oil/Gas indices rose by 0.42%, 1.98%, and 0.15%, respectively. On the flip side, the NGX Banking and the NGX Industrial indexes dwindled by 0.45% and 0.05%, respectively. Meanwhile, trading activity nosedived, with total volume, and value increasing by 63.96% and 9.52%, respectively, to 2.33 billion units, and N17.62 billion. In terms of volume, ACCESSCORP emerged as the most actively traded stock, with 1.23 billion shares worth N12.51 billion changing hands in 1,062 deals.



Money Market

NIBOR moved in mixed directions. Notably, short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), declined to 11.00% (from 11.13%) and 11.25% (from 11.50%), respectively.

Meanwhile, NITTY moderated across all tenor buckets, in tandem with the dwindling stop rates at yesterday's PMA.

Bond Market

In the OTC bond market, the value of plain vanilla FGN bonds was largely flat for the bulk of maturities tracked, even as the average yield on the secondary market expanded to 14.14%. Notably, the 10-year and 20-year yields were around 12.86% and 15.23%, respectively, cheaper by 8 basis points and 1 basis point. On the flip side, the 30-year debt was 52 basis points richer, while its corresponding yield decreased to 15.41% (from 15.49%). The 15-year yield remained steady at 14.75%.

Elsewhere, the value of the FGN Eurobond traded higher for most of the maturities tracked amid sustained bullish sentiment. Similarly, the average secondary market yield contracted to 12.80%.

Foreign Exchange Market

The Naira strengthened against the greenback, trading higher at N462 (from N462.13) at the Investors and Exporters (I&E) windows. Likewise, the parallel market appreciated by 0.27% to N738 (from N740).

Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude was up 0.12% to \$77.78 per barrel, while WTI crude gained 0.41% to \$74.61 per barrel.

Oil futures rose as supply constraints and falling US crude inventory outweighed global recession, monetary policy, and banking system concerns.

Gold was trading below \$2000 per ounce (-0.39%), pressured by improved investor risk appetite and an uptick in US Treasury yields as traders digested the weaker-than-expected US Q1 GDP (1.1% vs. exp 1.9%).
