
Local Bourse Index Falls by 0.75% amid Losses on BUACEMENT, ZENITHBANK Shares; NIBOR Declines for All Tenor Buckets on Liquidity Boost...

Investors sold their shares to convert paper profit to cash today despite the gainers (34) outnumbering the losers (20), hence the All-Share index declined by 0.75% to close at 52,209.06 points. Sell-offs were seen on BUACEMENT, AIICO, STANBIC, ZENITHBANK, DANGSUGAR, and WAPCO as their respective share prices declined by 8.02%, 1.69%, 1.33%, 0.41%, 0.26%, and 0.20%, respectively. Amid today's bearish turn, the year-to-date gain of the index mellowed to 1.87%. Performance across sub-indices tracked was largely negative except for the NGX Consumer Goods and the NGX Oil/Gas indexes, which rose by 1.30% and 0.93%, respectively. The NGX Banking, NGX Insurance, and NGX Industrial Indices decreased by 0.58%, 0.21%, and 3.40%, respectively. Meanwhile, trading activity nosedived further, with total deals, volume, and value decreasing by 9.08%, 13.52%, and 16.48%, respectively, to 5,168 trades, 554.31 million units, and N5.96 billion. In terms of volume, ACCESSCORP emerged as the most actively traded stock, with 139.29 million shares worth N1.47 billion changing hands in 640 deals.



## Money Market

NIBOR decreased across the board for all maturities tracked as gauges of money market stress eased and banks with liquidity demanded lower rates. Short-term benchmark rates, such as the open repo rate (OPR), remained unchanged at 11.00%, while the overnight lending rate (OVN), increased to 11.38% (from 11.33%), respectively. The three-month NIBOR rate further decreased by 16 basis points to close at 12.55%.

Meanwhile, NITTY moved in mixed directions, despite declining rates at today's PMA. Notably, the stop rates for the 91-day, 182-day, and 364-day bills moderated to 4.55% (from 5.30%), 6.44% (from 8.00%), and 8.99% (from 10.17%), respectively, due to improved liquidity conditions. Also, demand declined, as evidenced by a 5.70x bid-to-cover ratio (compared to 6.23x at the prior auction). The 182-day bills saw the highest demand (7.71x), followed by the 364-day (5.64x) and the 91-day bill (5.13x). Specifically, the average secondary market yield on T-bills moderated to 7.24% in tandem with declining marginal rates at the primary market.

## Bond Market

In the OTC bond market, the value of plain vanilla FGN bonds was largely flat for most maturities, despite the average yield on the secondary market contracting to 14.06%. The 10-year debt was 104 basis points richer, yielding 12.94% (from 13.30%), while the yield on the 15-year note ticked up 21 basis points to 14.96%. The 20-year and 30-year yields held steady at 15.23% and 15.84%, respectively.

Elsewhere, the value of the FGN Eurobond cleared higher for most of the maturities tracked on renewed bullish sentiment. Likewise, the average secondary market yield contracted to 13.13%.

## Foreign Exchange Market

The Naira weakened against the greenback, trading lower at N463.02 (from N462.25) at the Investors and Exporters (I&E) windows. Similarly, the parallel market depreciated by 0.50% to N744 (from N741).

## Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude fell 1.51% to \$76.27 per barrel, while WTI crude lost 1.62% to \$72.52 per barrel.

Oil futures fell on Wednesday amid rising demand concerns given the increase in US crude inventory stockpiles (+3.62 million barrels) from last week.

Gold was trading near \$2035 per ounce (+0.02%), as investors reacted to a lower-than-expected US CPI print (4.9% actual vs. 5.0% expected), which led to a downtick in the US treasuries.
