

### Cowry Daily Market Insight 16 May 2023

Bulls Hold Sway on Insurance, Consumer Goods Stock as ASI Inches by 36bps... NIBOR Eases on Improved Liquidity Levels

The bulls held sway on Tuesday as the benchmark index of the NGX inched further by 0.36% to close at 52,419.33 points while market cap swung up 0.36% to N28.54 trillion due to strong buying interests in insurance and consumer goods stocks. Also, the Exchange printed a higher number of gainers (26) than losers (19) as YTD rose to 2.28%. There were strong position-taking in NB, FTNCOCOA, SOVERINS, CORNERST and TRANSCORP which recorded positive price movements by 9.97%, 9.68%, 9.52%, 8.82%, and 7.79%, respectively. On the contrary, CWG (-9.63%), COURTVILLE (-6.52%), ARDOVA (-6.06%), and GLAXOSMITH (-4.41%) saw their prices nosedived due to profit booking. Performance across sub-indices was largely bullish as the NGX Insurance and the NGX Insurance indexes advanced by 3.19% and 1.10%, respectively, and was trailed by the NGX Consumer Goods and the NGX Industrial Indices with 0.85% and 0.06% gains respectively. Meanwhile, the NGX Oil/ Gas (-0.72%) was the loner. Furthermore, market activity was mixed, with total volume decreasing by 7.91% to 576.9 million units with an increased value of N6.79 billion. In terms of volume, UBA emerged as the most actively traded stock, with 94.3 million shares valued at N795.90 million changing hands in 373 deals.



#### Money Market

NIBOR traded southward across the board for all maturities tracked as gauges of money market stress lightened with the liquidity level trended positive. Short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), expanded to 13.38% (from 13.13%), and 14.13% (from 13.88%), respectively.

Meanwhile, NITTY trended higher for all tracked tenor buckets despite the average secondary market yield on T-bills staying muted at 6.65%.

#### **Bond Market**

In the OTC bond market, the value of plain vanilla FGN bonds was in a mix bag for most maturities, even as the average yield on the secondary market inched 5bps to 14.05%. The 10-year, 15-year, 20-year, and 30-year yields closed at 12.72%, 14.96%, 15.65%, and 15.73%, respectively.

Elsewhere, the value of the FGN Eurobond cleared lower for most of the maturities tracked on reversed bullish sentiment; consequently, the average secondary market yield closed at 13.12 from 13.15% at the last close.

#### Foreign Exchange Market

The Naira weakened against the greenback across all FX segments, trading lower at N464.67 (from N464) at the Investors and Exporters (I&E) windows. Similarly, the parallel market depreciated by 0.03% to N7468(from N747).

### Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude rose 0.06% to \$75.27 per barrel, while WTI crude gained 0.49% to \$71.45 per barrel.

Oil futures hovered around \$71 a barrel on Tuesday as investors began taking a count on global oil demand and supply due to expected tighter oil market conditions.

Elsewhere, gold prices skid to \$2,005 per ounce (-0.76%) as stalling US debt ceiling negotiations boosted appetite for non-yielding bullion
