
Bulls Maintain Grip as ASI Advances by 0.58%; NIBOR, NITTY Fall for Most Tenor Buckets amid Sustained Liquidity Ease...

At the end of Wednesday's trade, the domestic bourse index rallied by 0.58% to close at 52,927.60 points as investors digested the Q1 2023 GDP (-0.74% Y-o-Y) report from the NBS as well as a 50 bps MPR hike. Hence, the year-to-date gain of the NGX ASI rose to 3.27%. Consumer goods, banking, and oil/gas stocks dominated the top of the index as counters such as NESTLE, UACN, TOTAL, UNILEVER, ACCESSCORP, WAPCO, UBA, GERGEU, and SEPLAT were among the toast of investors today. Consequently, their respective share prices increased by 9.98%, 9.76%, 7.13%, 6.80%, 6.80%, 4.48%, 3.57%, 2.95%, and 2.13%. Breakdown across sectoral gauges indicated that four of the five sectorial gauges tracked closed in the green: the NGX Banking, NGX Consumer Goods, NGX Oil/Gas, and the NGX Industrial indices edged up by 1.06%, 2.07%, 2.54%, and 0.23%, respectively. On the flip side, the NGX Insurance index dwindled by 0.10%. Meanwhile, market activity improved, with total deals, volume, and value increasing by 11.59%, 29.69%, and 51.55%, respectively, to 6,635 trades, 455.18 million units, and N7.83 billion. In terms of volume, ACCESSCORP emerged as the most actively traded stock, with 69.19 million shares worth N755.72 million changing hands in 572 deals.



Money Market

NIBOR decreased across the board for all maturities tracked as gauges of money market stress eased and banks with liquidity demanded lower rates. However, short-term benchmark rates, such as the open repo rate (OPR), rose by 11.13% (from 11.00%), while the overnight lending rate (OVN) remained unchanged at 11.00%. Specifically, the three-month NIBOR rate fell by 15 basis points to close at 13.43%.

Meanwhile, NITTY traded lower for all tracked tenor buckets despite the average secondary market yield on T-bills closing flat at 6.84%.

Bond Market

In the OTC bond market, the value of plain vanilla FGN bonds was relatively flat for most maturities, despite the average yield on the secondary market expanding marginally to 14.01%. The 10-year, 15-year, 20-year, and 30-year yields held steady at 12.55%, 14.81%, 15.58%, and 15.77%, respectively.

Elsewhere, the value of the FGN Eurobond closed lower for most of the maturities amid renewed bearish sentiment; consequently, the average secondary market yield increased to 12.36%.

Foreign Exchange Market

The Naira weakened against the greenback, trading lower at N464.42 (from N463.50) at the Investors and Exporters (I&E) windows. Similarly, the parallel market depreciated by 0.06% to N761 (from N760).

Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude rose 1.42% to \$77.94 per barrel, while WTI crude gained 1.57% to \$74.05 per barrel.

Oil futures gained on Wednesday, buoyed by seasonal demand for energy, a drop in US crude stock (actual: -6.8 million barrels, expected: +0.8 million), and a likely OPEC+ output cut comment from the Saudi Energy Minister.

Elsewhere, gold was trading near \$1,968 per ounce (-0.38%), boosted by increased risk appetite for safe-haven assets as debt ceiling talks stalled, but constrained by a slightly stronger currency and rising US Treasury yields.
