

NGX ASI Increases by 0.16% on Sustained Bargain Hunting; NITTY Rises for Most Tenor Bucket amid Sell Pressure...

At the close of Tuesday's trading session, the domestic bourse index advanced by 0.16% to settle at 59,110.02 points amid sustained positive sentiment. Consequently, the year-to-date gain of the local bourse climbed to 15.33%. Notably, the bulls (50) outnumbered the bears (19) as investors hunted for bargains, particularly in small and large-cap stocks. Share prices of WAPIC, UBN, ETERNA, SEPLAT, GTCO, and DANGCEM expanded by 9.72%, 5.67%, 5.07%, 3.03%, 0.78%, and 0.14%, respectively. The insurance sector was investors' toast. As evidenced by a 1.85% increase in its index. Additionally, the NGX Banking, NGX Consumer Goods, NGX Oil/Gas, and NGX Industrial indexes rose by 0.02%, 0.06%, 1.41%, and 0.10%, respectively. Meanwhile, market liquidity was relatively constrained, resulting in a decrease in overall market activity, with total deals, volume, and value decreasing by 10.80%, 34.06%, and 19.61%, respectively, to 8,272 trades, 588.85 million units, and N8.96 billion. In terms of volume, UBA emerged as the most actively traded stock, with 78.51 million shares worth N907.47 billion changing hands in 438 deals.





Money Market

In the interbank market, NIBOR moved in mixed directions. Short-term benchmark rates, such as the open repo rate (OPR) and the overnight lending rate (OVN), were unchanged at 11.60% and 12.20%, respectively. Additionally, the three-month NIBOR rate increased by 19 basis points to 13.50%.

Meanwhile, NITTY traded higher for the bulk of tenor buckets tracked despite the average secondary market yield on T-bills closing flat at 6.60%.

Bond Market

In the bond space, the value of plain vanilla FGN bonds remained relatively flat across most maturities as investors digested yesterday's bond auction result. Notably, the average yield in the secondary market contracted to 13.48% amid increased interest on longer-dated notes. Specifically, 30-year borrowing costs yielded around 15.60% (from 15.64%), while 10-year and 20-year bond yields held steady at 14.23% and 15.35%, respectively.

Elsewhere, the value of the FGN Eurobond closed lower for all of the maturities tracked due to sustained bearish sentiment. Consequently, the average secondary market yield expanded further to 11.20%.

Foreign Exchange Market

In the FX space, the Naira appreciated against the US dollar, trading at N756.61 (from N770.38) at the Investors and Exporters (I&E) windows. On the other hand, the parallel market experienced a depreciation, falling by 0.15% to N759 (from N758). 1-month, 3-month, and 1-year Dollar/Naira forward rates closed lower at N735.98, N758.43, and 841.77, respectively, indicating losses of N19.18, N19.63, and N21.76.

Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude fell 2.11% to \$74.49 per barrel, while WTI crude lost 3.16% to \$69.66 per barrel.

Oil futures fell further on Tuesday, driven by the subdued Chinese energy demand outlook amid increasing deflationary pressure, which weighed negatively on market sentiment despite the PBOC's 10 bps trim of its 1-year and 5-year loan prime rate (LPR) to stimulate the economy.

Elsewhere, gold was trading near \$1,932 per ounce (-0.96%), pressured by a stronger dollar and a slower recovery in China. Also, traders positioned ahead of the upcoming Congressional testimony by the Chair of the US Federal Reserve, Jerome Powell.
