


MPR: 18.50% May'23 Inflation Rate: 22.41% Q1 2023 Real GDP: 2.31%

Bullish Trend Persists as the NGX ASI Rises by 1.61%; NIBOR Rises for Most Tenor Buckets amid Liquidity Strain...

The local bourse All-Share Index advanced by 1.61% to 61,949.24 points amid sustained positive sentiment, even as the Exchange printed 67 gainers as against 14 losers at the close of the trading session. Hence, the year-to-date gain of the NGX ASI increased to 20.87%. Bullish proceedings in the market were due to buy interest on Tier-1 banking stocks such as ACCESSCORP, UBA, GTCO, and ZENITHBANK; their respective share prices climbed by 9.94%, 9.80%, 4.29%, 7.14%, and 2.92%, respectively. Reflective of the bullish market sentiment, all of the five indexes tracked closed in green: the NGX Banking, NGX Insurance, NGX Consumer Goods, NGX Oil/Gas, and NGX Industrial indexes advanced by 6.78%, 1.84%, 0.52%, 1.50%, and 0.04%, respectively. Meanwhile, market activity remained strong, with total deals and volume increasing by 14.63%, and 20.78%, respectively, to 12,128 trades, and N14.04 million units. In terms of volume, FCMB emerged as the most actively traded stock, with 173.81 million shares worth N930.70 million changing hands in 490 deals.





Money Market

In the interbank market, the Nigeria Inter-Bank Offered Rate (NIBOR) decreased across most tenor buckets due to tighter liquidity conditions. Money market rates, such as the open repo rate (OPR), remained unchanged at 1.36%, while the overnight lending rate (OVN), declined to 1.14% (from 1.36%). Notably, the three-month NIBOR rate closed lower by 68 bps to 9.46%.

Meanwhile, NITTY traded lower for all of the tenor buckets tracked due to sustained demand pressure. Likewise, the average secondary market yield on T-bills fell to 6.34%.

Bond Market

In the bond space, the value of plain vanilla FGN bonds was bullish for the majority of maturities tracked, driven by buying interest in mid- and long-dated bonds. This offset marginal losses across short-dated debts and resulted in a further contraction of the average secondary market yield to 12.45%. Notably, the 21 JAN 2042 paper (richer by 105 bps) outperformed and led today's gains. Additionally, the 10-year, and 20-year borrowing costs yielded around 12.64% (from 12.74%) and 14.16% (from 14.25%), respectively, while the 30-year paper held steady at 14.69%.

Elsewhere, the value of FGN Eurobonds closed lower across most maturities, driven by sustained bullish activity. Conversely, the average secondary market yield expanded to 12.98%.

Foreign Exchange Market

In FX, the Naira strengthened against the US dollar at the Investors and Exporters (I&E) windows, trading at N741.50 (from N769.25). However, the parallel market experienced a depreciation, with the Naira falling 0.26% to N775 (from N773).

Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude rose 0.15% to \$75.53 per barrel, while WTI crude gained 0.20% to \$70.78 per barrel.

Oil futures were higher on Monday, as supply constraints resulting from Saudi Arabia's and Russia's planned August output cuts weighed on the market.

Elsewhere, gold was trading near \$1,930 per ounce (+0.53%), boosted by increased risk appetite for non-yielding bullion amid weak Manufacturing PMI readings, which pushed the US dollar and Treasury yields down.
