


MPR: 18.75% Jul'23 Inflation Rate: 24.08% Q1 2023 Real GDP: 2.31%

Equities Market Sustains Bullish Momentum as its All-Share Index Rose by 0.44%; NIBOR Increases for All Tenor Bucket amid Financial Liquidity Strain...

The domestic bourse sustained its positive momentum as its All-Share Index notched a 0.44% gain to close at 65,488.67 points amid sustained buy interest. Specifically, share prices of tickers such as BUAFOODS, NASCON, DANGSUGAR, GUINNESS, and TRANSCORP rose by 7.91%, 4.23%, 3.89%, 2.81%, and 2.28% respectively. Consequently, the year-to-date gain of the local bourse climbed to 27.78% despite the total number of losers (26) outweighing that of the gainers (16). The general market bullish mood was reflected in the sectoral performance as three of the five sub-gauges closed in the green – the NGX Insurance, NGX Consumer Goods, and the NGX Oil/Gas indexes rose by 0.53%, 3.75%, and 0.01% respectively. However, the NGX Banking and the NGX Industrial indices fell by 0.90% and 0.19%, respectively. Meanwhile, market activity improved, with total deals, volume, and value increasing by 7.30%, 26.71%, and 3.25%, respectively, amounting to 5,895 trades, 293.46 million units, and N4.12 billion. In terms of volume, MTNN emerged as the most actively traded stock, with 2.88 million shares worth N791.46 million changing hands in 296 deals.





#### Money Market

The money market saw an increase in NIBOR rates across all tenor buckets due to a sustained liquidity squeeze. Notably, the three-month NIBOR rate witnessed an increase of 19 basis points, reaching 13.50%. Key money market rates, including the open repo rate (OPR) and the overnight lending rate (OVN), ticked upwards to settle at 23.80% (previously 22.50%) and 24.70% (previously 23.30%), respectively.

NITTY displayed an upward trend across most tracked tenors. However, the average secondary market yield on Treasury bills moderated to 8.28%.

#### **Bond Market**

In the OTC bond market, the values of FGN bonds moved in mixed directions for most maturities tracked. However, sell-offs across the curve, particularly in the 18 MAR 2036 bond, led to an expansion in the average secondary market yield to 13.62% (from 13.54%). Notably, the 10-year borrowing cost yielded around 14.22% (from 14.26%), while the 20-year and 30-year papers held steady at 15.19% and 15.30%, respectively.

Elsewhere, FGN Eurobonds saw depreciation across most tracked maturities, driving the average secondary market yield higher to 11.24%.

### Foreign Exchange Market

The Naira weakened further against the US dollar both at the official windows (trading at N770.72 from N761.32) and in the parallel market (depreciating by 4.65% to N900).

### Global Commodity Market

At 3:30 p.m. GMT+1, Brent crude fell 0.15% to \$84.33 per barrel, while WTI crude lost 0.36% to \$79.83 per barrel.

Oil futures were lower on Tuesday, as demand concerns lingered despite a PBOC lending rate cut failed to stimulate the market.

Elsewhere, gold was trading near \$1,897 per ounce (+0.18%), driven by dwindling demand for non-yielding bullion as US Treasury yields rebounded. Source: FMDQ, Trading Economics, OilPrice.com, S&P Dow Jones, Cowry Research
