

#### Positive Interest in JBERGER, CWG Shares Jolts ASI Up by 43bps; NIBOR Falls for Most Tenor Buckets on Liquidity Strain...

Nigeria's stock exchange on Tuesday closed bullish as the benchmark index advanced by 0.43% to settle at 67,326.12 points while the market cap of listed equities rose in the same manner to N36.99 trillion. This comes as investors begin to show expectations for Q3 earnings results and renewed bullish sentiment in the face of current level of volatility, and as a result, the exchange printed more gainers (27) ahead of laggards (22). As such, JBERGER, CWG, CHAMPION, OANDO, THOMASWY were the top toast for investors as their respective share prices increased by 10.00%, 9.83%, 9.76%, 9.58% and 9.29% respectively. Breakdown across the sectoral gauges showed a bullish outing as four of the five indices tracked closed in the green zone: the NGX Banking, NGX Insurance, NGX Oil/Gas and NGX Industrial Goods indices rose by 2.75%, 0.20%, 0.03% and 0.05% respectively. On the flip side, NGX Consumer Goods index showed a mild decline by 1bp. Meanwhile, market activity was positive, with total deals, volume, and value rising by 12.81%, 74.93% and 45.57% respectively, amounting to 6,729 trades, 377.97 million units, valued at N5.17 billion. ETRANZACT was the most actively traded stock by volume, with 44.07 million units worth N370.15 million in 20 deals.





### Money Market

In the money market, NIBOR rates closed lower for all tenor maturities even as the overnight NIBOR advanced by 0.37% points to reach 2.00% indicating the level of illiquidity in the financial system. However, key money market rates such as the open repo rate (OPR) and overnight lending rate (OVN), was unchanged at 0.94% and 1.50% from previous close

In the same vein, the Nigerian Interbank Treasury Bills True Yield (NITTY) cleared higher across most of the tenors to mirror the level of secondary market activities. Meanwhile, there was an exhibition of bearish sentiment in SEPT-24 instrument which pushed the average treasury bills yield in the secondary market by a basis point.

#### **Bond Market**

In the secondary market for FGN Bonds, market activity was largely quiet even as the value of the FGN debt instrument closed flat for all maturities. Meanwhile, the JUN-53 debt paper was the worse performer on Tuesday on the back of sell-off which drove the average yield in the bond market higher by a base point.

In Nigeria's Eurobonds market, there was sustained bearish momentum across all maturities as the value of the Sovereign FGN instrument tanked across tracked maturity gauges. Meanwhile, the average secondary market yields closed negative by 14bps primarily driven by sell sentiment in NOV-25.

### Foreign Exchange Market

In the foreign exchange market, the Naira routed further in the negative territory by 8.90% at the I&E (Investors and Exporters) window, closing at N848.12 to the dollar from N778.80 per dollar the previous day after failed FX policy reversal. Meanwhile, in the parallel market, the Naira depreciated on the back of unabating demand to close at N1,060 per dollar.

## **Global Commodity Market**

At 3:30 p.m. GMT+1, Crude oil price traded around the \$90 mark despite the news within the market that the U.S plans to ease sanctions on Venezuela's oil export. Meanwhile, the WTI traded slightly above \$85 per barrel while the Brent Crude price hang around the \$89 market on brewing positive sentiments.
