

Upbeat Performance as NGX-ASI Advances Northward by 0.19%; Nibor Crashes on System Liquidity Ease.....

The local bourse maintained its positive trend, with its All-share index rising by 0.19% to close at 70,613.60 points, although the number of losers (25) outweighed that of the gainers (22) at the close of the trading session. Consequently, the year-to-date gain of the local bourse rose to 37.78% as market cap reached N38.80 trillion. Specifically, stocks such as PZ, GLAXOSMITH, DAARCOMM, JAPAULGOLD and INTBREW enjoyed investors' patronage as their respective share prices surged by 10.00%, 9.93%, 9.52%, 9.35% and 8.43%, respectively indicating a bullish market mood. Furthermore, performance by sub-sector index pointed to bullish sentiment as the NGX Banking Index, NGX Insurance Index, NGX Consumer Goods Index and NGX Industrial Goods Index gained by 0.01%, 0.15%, 0.31%, and 0.03% respectively while bearish sentiment claimed the NGX Oil/Gas Index as it fell by 0.27%. Market activity showed further improvement as the total deals and traded volume for the day soared by 3.85% and 14.90% to 7,100 trades and 449.28 million units. However, the total value for the day declined by 29.34% to N5.44 billion. FBNH was the most traded security in terms of volume and value with 52.02 million units worth N1.03 billion traded during the Tuesday session, changing hands in 373 deals.





### Money Market

In the money market, NIBOR decreased across the board for all of the maturities tracked signifying further improvement on system liquidity. Key money market rates, including the open repo rate (OPR) and the overnight lending rate (OVN) increased by 0.25% and 0.41% to reach 16.32% and 17.29% respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) continued to rise across all tenor options. In the secondary market for Nigerian Treasury Bills, the average secondary market yield fell flat at the close of the trading session.

## Bond Market

The secondary market for FGN Bonds was bearish at the close of Tuesdays' trading session as the average yield slightly rose by 12bps to close at 15.75%. This was as a result of the MAR-25 FGN bond being the worst performer with yield expansion of 0.76%.

In Nigeria's sovereign Eurobonds market, there was a negative level of activity. Sell sentiment was evident across the short, mid, and long ends of the yield curve, thus leading to the average yield increasing by 12 bps to hit 11.04% at the close of the session.

## Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 7.53%, closing at N869.91 to the dollar in the official market, compared to the previous rate of N809.02.

On the contrary, in the parallel market, the Naira's performance continued to strengthen as the local currency closed at N1,030 per dollar on Tuesday, compared to N1,035 previously. This suggests that the demand pressure for the US dollar has been easing in the parallel market.

## **Global Commodity Market**

At 3:30 p.m. GMT+1 on Tuesday. Brent crude dropped by 2.56% to \$82.99 per barrel, while the West Texas Intermediate (WTI) crude oil also declined by 2.49% to \$78.80 per barrel.
