
## Cowry Daily Market Insight 09 November 2023

ASI Tends Higher by 7bps on Strong Buy-Interest; NIBOR Moderates for Most Tenor Buckets.....

The NGX All-Share index advanced by 0.07% to close at 70,819.58 points to register four consecutive days of bargain hunting. Hence, the year-to-date gain of the NGX ASI climbed to 38.18% despite the Exchange printing a higher number of losers (27) as against gainers (26). Share prices of stocks such as UPDC, MECURE, SCOA, JAPAULGOLD and UACN closed higher by 9.91%, 9.85%, 9.73%, 9.58% and 8.47%, respectively. A breakdown across sub-sector gauges tracked indicated broad-based losses as most of the sub-indices tracked closed southwards: the NGX Insurance, the NGX Consumer Goods, and the NGX Industrial indices fell by 1.05%, 0.06% and 0.02%, respectively. On the flipside, the NGX Banking index experienced gains of 0.21%, while the Oil/Gas sector had a lull performance. Meanwhile, market activity was bullish as the total volume rose by 1.94% to 569.19 million units while the traded value surged by 71.44% to N16.79 billion; although, the total deals for the day declined by 3.62% to 6,169 trades. JAPAULGOLD was the most traded security in terms of volume with 113.96 million units worth N208.55 million traded during the Thursday session, changing hands in 174 deals.







### Money Market

In the money market, NIBOR decreased across the board for most of the maturities tracked. The Overnight, 3-month and 6-month NIBOR declined by 0.08%, 0.25% and 0.17% respectively, while the 1-month NIBOR increased by 0.08%. Key money market rates, including the open repo rate (OPR) and the overnight lending rate (OVN) increased by 0.38% and 0.21% to 16.88% and 17.63% respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) closed higher on Thursday across all tenor gauges. Additionally, the average secondary market yield on Nigerian Treasury Bills experienced a bullish trend, decreasing by 94 basis points to 13.37%.

### **Bond Market**

The secondary market for FGN Bonds traded in the mix on Thursday as the average yield slightly declined by 9bps to 15.67% due to yield reduction by 223bps seen in the MAR-24 FGN paper.

In Nigeria's sovereign Eurobonds market, activity level was bearish as sell sentiment seen in most maturities led to a slight increase in the average yield higher by 14bps to 11.21% on Thursday.

### Foreign Exchange Market

In the foreign exchange market, the Naira further depreciated by 13.95% closing at N996.75 to the dollar from N874.71 per dollar the previous day. In the parallel market, the Naira traded weak on Thursday, closing at N1,140 against the US dollar.

## **Global Commodity Market**

At 3:30 p.m. GMT+1 on Thursday. Brent crude increased by 1.42% to \$80.67 per barrel, while the West Texas Intermediate (WTI) crude oil also rose by 1.44% to \$76.42 per barrel.
