Domestic Bourse Sees Modest 0.12% Gains as Positive Sentiment Continues; NIBOR Rises for All Tenor Buckets on Liquidity Strain.....


The domestic stock market All-Share index advanced by 0.12% on Friday to close the week on a positive note, settling at 71,112.99 points as investors repositioned in stocks with good fundamentals. Hence, the year-to-date gain of the index increased to 38.75%, even as the exchange recorded a higher number of gainers (36) than losers (19). Notably, we saw buying interest in symbols such as MULTIVERSE (+10.00%), PRESTIGE (+10.00%), MECURE (+9.98%), CILEASING (+9.93%), and NNFM (+9.89%). Given the bullish momentum, the NGX Insurance, and NGX Oil/Gas indexes rose by 1.40%, and 3.71%, respectively. However, the NGX Consumer Goods and NGX Industrial Goods indexes fell by 0.07% and 0.04% respectively, while the NGX Banking index was flat. Meanwhile, market activity dwindled, with total deals and volume decreasing by 10.11% and 8.74%, amounting to 5,883 trades and 441.58 million units, respectively. The total traded value bucked the trend, advancing by 37.77% to N6.03 billion. JAIZBANK was the most actively traded stock, with 95.21 million shares worth N153.24 million changing hands in 113 deals, while GTCO was the most traded in terms of value, amounting to N1.31 billion.





Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) trended higher across all tracked maturities. Notably, the overnight NIBOR rose by 1.58% to 23.83%. Conversely, key money market rates, including the open repo rate (OPR) and the overnight lending rate (OVN) decreased by 1.38% and 0.72% to 20.83% and 22.20%, respectively.

In the Nigerian Interbank Treasury Bills market, the Nigerian Interbank Treasury Bills True Yield (NITTY) observed upward trend across most of the tracked tenors. However, In the secondary market for Nigerian Treasury Bills, there was a positive level of activity which led to a decline in the average yield by 36bps to 12.97%.

Bond Market

In the secondary market for FGN Bonds, trading on Friday exhibited bullish results as the average yield declined by 6 basis points (bps) to close at 15.73%. This was as a result of positive Interest in the MAR-24 instrument.

In Nigeria's sovereign Eurobonds market, there was a positive level of activity. Buy sentiment was evident across the short, mid, and long ends of the yield curve, leading to a decrease in the average yield by 16bps to 10.96%.

Foreign Exchange Market

In the foreign exchange market, the Naira had a mixed performance against the US dollar. The Naira appreciated by 5.87% in the official market, closing at N791.75 to the dollar compared to the previous rate of N841.14. On the contrary, in the parallel market, Naira depreciated by 6.17% to close at N1,135 per dollar.

Global Commodity Market

At 3:30 p.m. GMT+1 on Friday. Brent crude advanced by 2.19% to \$79.12 per barrel, while the West Texas Intermediate (WTI) crude oil also increased by 2.15% to \$74.47 per barrel.
