

The Bulls Resurface as NGX ASI Surges by 8bps on Strong Buy Momentum; Naira Crashes Across FX Markets.....


The local bourse reversed Mondays' losses as the NGX ASI advanced by 0.08% to close at 71,066.55 points and as a result, investors recorded total gains of N31.81 billion, even as the Exchange posted a rather large sum of gainers (45) as against the losers (8) at the close of Tuesday's session. LEARNAFRICA, MECURE, NNFM, CADBURY and MULTIVERSE were the major tickers of investors for the day as their respective share prices recorded an upward trajectory of 10.00%, 10.00%, 9.90%, 9.78% and 9.77%. Reflective of the bullish market momentum, performance across the sub-sector gauges was positive with the NGX Banking, NGX Insurance and NGX Industrial Goods indexes advancing by 0.46%, 2.13% and 0.08% respectively. However, despite the favorable market condition, the Consumer Goods sector recorded a loss of 0.04%, while the Oil/Gas sector remained quiet. Meanwhile, market activity mellowed, as the total deals and value declined by 0.03% and 26.07% to 6,549 trades and N3.22 billion, respectively. However, the total traded volume for the day surged by 37.09% to 491.40 million units. At the conclusion of the trading session, UNITYBNK emerged as the most actively traded security, with a total traded volume of 75.44 million units valued at N105.35 million, involving 375 trades, while VFDGROUP was the most traded in terms of value, amounting to N481.81 million.



### Money Market

In the money market, the Nigerian Interbank Offered Rate (NIBOR) trended lower across most of the tracked maturities, with the exception of the Overnight NIBOR which advanced by 1.16% to 23.83%. Additionally, key money market rates, including the open repo rate (OPR) and the overnight lending rate (OVN) decreased by 0.17% and 0.05% to 22.93% and 23.83%, respectively.

The Nigerian Interbank Treasury Bills True Yield (NITTY) closed in the mix for the tracked tenors. The 1-month and 12-month NITTY declined by 0.23% and 1.64%, while the 3-month and 6-month NITTY advanced by 0.10% and 0.11%, respectively. However, the average secondary market yield on the Nigerian Treasury Bills was in the bullish region as it moved 6bps to close at 12.67%.

### **Bond Market**

In the secondary market for FGN Bonds, market activity was largely in a quiet mode on Tuesday, and as a result the average yield remained unchanged at 15.81%.

In Nigeria's sovereign Eurobonds market, the FGN Eurobonds was relatively bullish for the maturities tracked, with the average secondary market yield rebounding by 17bps to close at 10.81%.

### Foreign Exchange Market

In the foreign exchange market, Naira crashed across the FX markets. The Naira depreciated by 10.78% in the official market, closing at N830.97 to the dollar. In the same vein, in the parallel market, Naira depreciated by 0.18% to close at N1,140 per dollar.

## **Global Commodity Market**

At 3:30 p.m. GMT+1 on Tuesday. Brent crude declined by 0.79% to \$82 per barrel, while the West Texas Intermediate (WTI) crude oil also declined by 1.03% to \$77.03 per barrel.
