

December Opens Bullish as ASI Notches 8bps, Sparking Investor Optimism; Naira Edges the dollar to N927.19....

At the close of the trading session for the week, the local stock closed with a positive gain of 0.08% as the benchmark index continued its positive streak, reaching a new level of 71,419.87 index points. The market cap of listed equities also saw a commendable uptick of 0.08%, reaching N39.08 trillion, even as the exchange recorded a higher number of gainers (38) as against losers (27). IKEJAHOTEL, NEIMETH, UNITYBNK, OMATEK and THOMASWY were the major tickers of investors for the day as their respective share prices recorded an upward trajectory of 10.00%, 10.00%, 10.00%, 9.86% and 9.65%. Across the sectors, waning investor sentiment was observed in Insurance, Consumer Goods and Industrial Goods indexes, as they declined by 1.10%, 0.08% and 0.06%, respectively. On the flipside, buy pressure was evident in the Banking and Oil/Gas indexes, thus recording advancements of 1.14% and 0.05%. Despite the positive market index, trading activity worsened, as the total deals, volume and value experienced declines of 13.44%, 33.14% and 0.17%, amounting to 5,640 deals, 361.12 million units, worth N10.23 billion, respectively. At the conclusion of the trading session, UNIVINSURE emerged as the most actively traded security in terms of volume with 44.08 million units worth N11.77 million, across 79 deals, while DANGCEM was the most traded in terms of value, amounting to N5.29 billion.





### Money Market

In the money market, the Overnight NIBOR exhibited a 0.55% decrease, closing at 17.25%, indicating improvement in the liquidity system. Conversely, the 1-month, 3-month, and 6-month NIBOR rates increased to 16.75%, 16.75%, and 17.75%, respectively. Key money market rates, including the open repo rate (OPR) and overnight lending rate (OVN), experienced upward trends on Friday, reaching 15.75% and 16.32%, respectively.

The Nigerian Interbank Treasury Bills market saw a decline in yields across various tenor options, with the NITTY rates falling by 0.11%, 0.16%, and 0.02% for the 1-month, 6-month, and 12-month options. In the secondary market for Nigerian Treasury Bills, negative interest at the longer end of the yield curve was observed, resulting in an average T-bills closing higher at 10.50%.

### **Bond Market**

Moving to the bond market, trading activity was bullish, mostly driven by the JAN-26 FGN paper, thus dragging the average yield on FGN Bonds lower by 3bps to 15.69%.

In Nigeria's sovereign Eurobonds market, sell sentiment prevailed across the short, mid, and long ends of the yield curve, causing a 6bps increase in the average yield to 10.63%.

### Foreign Exchange Market

Shifting to the foreign exchange market, the Naira showed a lackluster performance against the US dollar, depreciating by 11.40% in the official market to close at N927.19. In the parallel market, the Naira depreciated by 0.09% day-on-day to close at N1,163 per dollar due to sustained demand for the dollar.

### **Global Commodity Market**

In the global commodity market, oil prices experienced a positive trend, with Brent Crude trading at \$80.96 per barrel and WTI at \$76.11 per barrel on Friday.
