

Banking Stocks Sell-Off Interrupts ASI 5-Day Bullish Run; NIBOR Trends Higher on Rising Liquidity Crunch....

The domestic equities market ended its Santa Rally on Friday as the NGX All-Share Index witnessed a downward movement of 0.09% to end the trading week at 72,389.23 points, as the year-to-date gain of the index settled at 41.24%. Notable Sell-Offs were observed in key banking stocks such as FBNH, ACCESSCORP and UBA as they contributed to the negative sentiment in the market. UNIVINSURE, LIVESTOCK, FBNH, FTNCOCOA and OANDO experienced significant price declines thus emerging the top losers for the day. Despite the Exchange printing a higher number of gainers (38) than losers (16), the market cap of listed equities declined by 0.09% to N39.61 trillion, as investors recorded a total market loss of N36.44 billion. Trading activity on the NGX showed further decline with the total deals, volume and value plummeting by 12.11%, 31.22%, and 9.49% to 6,016 trades, 307.15 million units and N6.57 billion, respectively. Performance across the sub-sector gauges tracked was largely bullish as the Insurance, Consumer Goods, Oil/Gas and Industrial Goods indices recorded gains of 0.82%, 0.36%, 0.94% and 0.01%, respectively. However, the Banking sector was the only laggard, declining by 0.72%. At the conclusion of the trading session, GTCO emerged as the most actively traded security in terms of volume and value with 51.08 million units worth N2.04 billion, across 225 trades.



# Money Market

In the money market, NIBOR rates trended higher across tenor buckets. There was a notable 3.21% day-on-day increase in the Overnight NIBOR reaching 23.00%, indicating liquidity strain in the financial system. Key money market rates, such as the open repo rate (OPR) and overnight lending rate (OVN), increased by 2.60% and 2.85% to close at 22.25% and 23.25%, respectively.

In the Nigerian Interbank Treasury Bills market, yields across the tenor options decreased, with NITTY rates dropping by 0.64%, 0.89%, 1.35% and 0.64% for the 1-month, 3-month, 6-month and 12-month options. The secondary market for Nigerian Treasury Bills witnessed mild positive activity on Friday as the average T-bills yield declined by a base point to settle at 8.29%.

# **Bond Market**

Moving to the bond market, trading activity across the short and midend of the curve was positive, thus resulting in a decrease in the average yield by 6bps to 14.38%.

In Nigeria's sovereign Eurobonds market, buy sentiment prevailed across the short, mid and long ends of the yield curve, causing a decline of 8bps in the average yield to 9.92%.

# Foreign Exchange Market

Shifting to the foreign exchange market, the Naira appreciated by 1.25% at the official market to close at N889.86 per dollar (from N901.14). Similarly, in the parallel market, the Naira also appreciated by 0.89% to close at N1,223.

# **Global Commodity Market**

In the global commodity market, oil prices showed a negative trend, with Brent Crude decreasing by 0.20% to trade at \$76.46 per barrel and WTI also dropping by 0.44% to trade at \$71.27 per barrel on Friday.
