

ASI Hits Record 100k Milestone as Investors Reap N1.62 Trillion in Historic Rally; NIBOR Dips as System Liquidity Improves....

The domestic equities market sustained its positive momentum as its All-Share Index notched a 3.00% gain to hit a new record of 101,571.11 points, as investors reaped N1.62 trillion in historic rally. Specifically, share prices of stocks such as WAPIC, BUACEMENT, JAPAULGOLD, UPL and TRIPPLEG rose by 10.00%, 9.98%, 9.91%, 9.82% and 9.69%, respectively. Consequently, the year-to-date gain of the local bourse climbed to 35.84%, as the Exchange recorded a higher number of gainers (35) than losers (32). Resultantly, the market capitalization of listed equities experienced a surge of 3.00% to N55.58 trillion. NEM, CADBURY, TIP, MAYBAKER and MCNICHOLS emerged as the top five decliners for the day, as they experienced unfavorable share price movement of -10.00%, -9.96%, -9.92%, -9.89% and -9.88%, respectively. The general market bullish mood was reflected in the sectoral performance as three of the five sub-sector gauges closed in the green. The Industrial Goods sector led the gainers with a 7.64% increase, buoyed by buy interest in BUACEMENT, DANGCEMENT and WAPCO, followed by the Consumer Goods and Oil/Gas indexes with gains of 4.07% and 0.09%. However, the Banking and Insurance indexes posted losses of 0.61% and 1.52%, respectively. Notwithstanding the positive momentum of the ASI, tepid trading was observed on the stock exchange. The total deals, volume and traded value nosedived by 27.18%, 34.65% and 50.62% to 12,080 trades, 488.49 million units and N8.04 billion, respectively. At the conclusion of the trading session, TRANSCORP took the spotlight as the most traded security in terms of volume and value with 95.11 million units worth N1.59 billion, traded across 1,207 deals.



Money Market

In the money market, NIBOR rates trended lower across all tenor buckets reflecting improvement in the financial liquidity system. This is as a result of the N1.13 trillion FAAC inflow into the financial system. Consequently, the Overnight, 1-month, 3-month and 6-month NIBOR rates declined by 0.81%, 0.56%, 0.75% and 0.75%, respectively. Key money market rates, including the open repo rate (OPR) and overnight lending rate (OVN), nosedived and concluded at 18.80% and 19.95%, respectively.

In the Nigerian Interbank Treasury Bills market, yields across various tenor options declined by 0.16%, 0.18%, 0.67% and 0.37% for the 1-month, 3-month, 6-month and 12-month periods. Meanwhile, the average secondary market yield on Nigerian Treasury Bills was bearish thus increasing by 2.35% to close at 6.47%.

Bond Market

In the secondary market for FGN Bonds on Wednesday, trading activity was bearish, leading to a slight increase in the average yield by 0.01% to 13.59%.

In Nigeria's sovereign Eurobonds market, the prevailing sentiment was bearish across the yield curve, causing an increase of 0.02% in the average yield to 10.14%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated by 0.41% at the official market, closing at N882.24 to the dollar from N878.61 per dollar the previous day. In the parallel market, the Naira closed at N1,357 against the US dollar.

Global Commodity Market

In the global commodity market WTI crude futures advanced by 1.00% to \$75.12 per barrel on Wednesday. Also, the Brent Crude increased by 0.70% to close at \$80.11 per barrel.
